"RADIO CHAIN (NEW BRUNSWICK), LIMITED"

Public Notice is hereby given that under "The New Brunswick Companies' Act" (being Chapter 88 of the Revised Statutes 1927), Letters Patent have been issued under the seal of the Provincial Secretary-Treasurer of the Province of New Brunswick, bearing date the Second day of February, A. D. 1931, incorporating, Luella Dunn, Vice-President; of the City of Saint John, in the County of the City and County of Saint John and Province of New Brunswick; Robert A. Ross, Manager; and Morrison D. Earle, Manager; both of the Parish of Lancaster, in the County of the City and County of Saint John and Province aforesaid, for the following purposes, namely:

To manufacture, buy, sell, import, export, exchange and generally deal in all kinds of radio machines, radio telephones, wireless telephones and all kinds of radio and wireless equipment and apparatus, electrical machines, appliances, fixtures and parts thereof and accessories thereto and supplies therefor, and all apparatus and material used in the manufacture, installation and supply of any and all of the same.

To manufacture, buy, sell, import, export, exchange and generally deal in all kinds of electric vacuum and cleaning machines, refrigerators and refrigerating appliances, electric heaters and cookers, and other electrical appliances, accessories, supplies, apparatus and material.

To manufacture, buy, sell, import, export, exchange and generally deal in all kinds of phonographs, pianos, organs and musical instruments and parts thereof and accessories thereto, with all books, sheet music, records and supplies sold by a music dealer.

To manufacture, buy, sell, import, export, exchange and generally deal in all kinds of furniture and furnishings, mats, rugs, carpets and machinery, household supplies, appliances and equipment and all goods and material used in any of the same.

To manufacture, buy, sell, import, export, exchange and generally deal in all kinds of books, papers, periodicals and other printed matter and supplies, pictures, ornaments and novelties.

To carry on business as merchants dealing in all classes of merchandise usually carried in stock by jewellers, silversmiths, watchmakers and clockmakers.

To carry on a general mercantile business as importers and dealers in all kinds of goods, wares and merchandise, whether wholesale or retail, and by means of stores, warehouses, shops or agencies in all such places as the Company may deem to be profitable and advantageous.
