and repair station.

To establish depots and agencies and to promote trial tests for motors and appliances in connection therewith, including carburetors and fuel-saving de-vices, and to offer for competition and distribution, prizes in connection thereTo keep, maintain, operate and manage garages, storehouses, storerooms, warehouses, vulganizing plants, service safekeeping, cleaning, repairing and care stations and other like places for the generally, of automobiles and motor cars of all and every kind, description and class, and of all the accessories thereof and thereto of any and every kind and description. description.

To rent and lease and hire motor cars, trucks and automobiles of all kinds, car-ry and transport passengers and freight in same upon such terms and conditions

ry and transport passengers and freight in same upon such terms and conditions as the Company may consider advisable. To buy, sell, export, import and exchange and generally deal with, as agents or principal, in all kinds of frigidaires and accessories.

To buy, sell, export, import and deal in generally all kinds of radios, dictaphones, phonographs and all accessories and parts pertaining thereto.

To acquire, hold, mortgage, sell and convey any and all real estate requisite for the carrying on of the Company or the objects pertaining thereto.

To do all acts and things that the Company may desire in any manner, connected with the business as is hereby authorized to be carried on by the said Company or connection thereof, necessarily incidental, convenient or auxiliary thereto or calculated directly or indirectly to promote the interest of the Company or enhance the value of or render profitable any of the properties and rights.
