New Brunswick Dental Act, March, 1929

Section 24—Each registered dentist or dental surgeon shall on or before the first day of January in each year shall pay to the Secretary-Treasurer or any person deputed by the Secretary-Treasurer to receive it, such annual fee as may be determined by by-law of the Council, not less than two dollars nor more than ten dollars and such fee shall be deemed to be a debt due by the registered dentist and be recoverable with costs in th name of the Society in any court of competent jurisdiction.

Section 25 (1)—Upon every such payment he shall receive a certificate under the seal of the Society; any member falling to make such payments shall forfeit his place upon the register and he shall thereupon cease to be deemed to be registered; and if any such fee remains due from any dentist or dental surgeon on the Fifteenth day of January in any year, the name of such person shall not be printed or published in the Royal Gazette in such year, as provided in Section 28, but any such practitioner upon the payment of all arrears of such fees, shall thereupon be registered and be deemed registered from the time of such payment.
