

**"THE SHEDIAC INN, LIMITED"**

Public Notice is hereby given that under "The New Brunswick Companies' Act" (being Chapter 88 of The Revised Statutes 1927), and amending Acts, Letters Patent have been issued under the seal of the Provincial Secretary-Treasurer of the Province of New Brunswick, bearing date the First day of April, A. D. 1931, incorporating Thomas Babin, Manager; Harold Babin, Broker, and Ferdinand J. Robidoux, Attorney-at-Law; all of the Town of Shediac, in the County of Westmorland and Province of New Brunswick; for the following purposes, namely:

To construct, build, purchase, lease, own, equip, maintain and operate hotels, restaurants, cafes and refreshment rooms, and sell, lease, supply exchange or otherwise dispose of the same, and generally to carry on in all its branches the business of building, owning, maintaining and operating hotels, restaurants, cafes, taverns, refreshment booths and lodging houses and, in connection therewith, to carry on the business of licensed victuallers, tobacco merchants, importers and manufacturers of aerated, mineral and artificial waters and other drinks, purveyors, caterers for public amusements generally, automobile, coach, cab and carriage proprietors, livery stable keepers, real estate agents, brokers, carriers and warehousemen, and to do any and all lawful business incidental or in any way connected with the purposes or any of them.

To remunerate whether by means of commissions or otherwise any persons or companies for subscribing to or agreeing to subscribe for any shares of the Company, or any debentures, debenture stock or other securities of the Company, or for services rendered or to be rendered in placing or assisting to place or guaranteeing the placing of any shares of the Company or any debentures, debenture stock or other securities of the Company or in or about the formation or promotion of the Company or the conduct of its business.

To issue and allot as fully or partly paid-up shares of the Company in payment or part payment of any business, franchise, undertaking, property, rights, powers, privileges, leases, licenses, contracts, real estate, stocks, bonds and debentures or other property or rights which it may lawfully acquire by virtue of the powers herein granted, or of any services rendered or to be rendered to the Company, by the name of "The Shediac Inn, Limited," with a capital stock of One Hundred Thousand Dollars divided into Five Hundred Preference Shares of One Hundred Dollars Each and Five Hundred Common Shares of One Hundred Dollars Each.

The said Preferred Shares shall before dividends are paid upon any other shares be entitled to a fixed cumulative preferred dividend to the extent of Seven Per Centum Per Annum upon the par value thereof, payable quarterly, and in any distribution of the assets of the said Company upon winding up, dissolution or sale thereof, or other termination of the said Company, said shares of Preferred Stock shall on the par value thereof together with any accrued unpaid dividends cumulated at said rate, be entitled to a preference over all other shares of stock of said Company, but all or any of said shares of Preferred Stock may be retired by the said Company at any interest date, such retiring to be at par value plus any accrued unpaid dividend cumulated at the rate aforesaid and plus a premium of Five Per Cent upon said par value.

The holders of shares of Preferred Stock shall not be entitled to share beyond the fixed cumulative dividend aforesaid, but shall have the right to vote as Shareholders at all meetings of the Company.

The Directors may issue and allot Common Stock of the Company fully paid up and non-assessable as a Bonus to subscribers for Preference Stock, with the Head Office at the Town of Shediac in the County of Westmorland and Province of New Brunswick.

**Supplementary Letters****"EASTERN CANADA COASTAL STEAMSHIPS, LIMITED"**

**Dept. Lands and Mines****PROCLAMATION**

In accordance with the authority given me under Section 42 of Chapter 32 of The Revised Statutes, 1927, all the forest land in the Province of New Brunswick is hereby proclaimed "A Protected Area" in accordance with the following regulations, namely:

(1) No person shall enter upon any area of forest land, after May 1st, 1931, until November 1st, 1931, for the purpose of travelling, camping, or fishing or picnicking or for any other purpose without having first registered with a local fire warden or other person duly authorized giving his name, the route, destination, purpose and duration of the trip with dates, and having obtained a Forest Travel Permit. Such permit shall be produced when requested by any fire warden or other authorized person provided that the following persons shall not be subject to the above regulations, namely: Licensees or owners or occupiers of the forest lands travelled on, or their employees, or any fire wardens, fire fighters, land surveyors, licensed guides, or persons accompanied by licensed guides, or holders of hunting, fishing, prospecting and mining licenses or leases; or Clergymen, Teachers pupils accompanied by Teachers, Scout Masters and Scouts when accompanied by Scout Masters.

(2) Any person who is not required to secure a forest travel permit must when entering or travelling upon forest lands carry an identification card, badge, certificate or license as the case may be, and must exhibit the same and give information with regard to the route, destination, purpose and duration of the trip with dates when so required by any Fire Warden or other authorized person.

(3) Any person holding a forest travel permit under Section 43, Chapter 32, R. S. 1927, or any person exempted by subsection 3 of Section 42 of the same Act, from securing a forest travel permit, who enters or leaves forest lands on roads, trails or other routes of travel where registering stations are provided and designated by notices, issued under authority of the Minister of Lands and Mines, as official "Forest Travel Registering Stations" must stop at such places of registration and report to the fire warden or other authorized officer there, giving such particulars as are required of the route, destination, purpose and duration of the trip with dates.

Penalties for non-compliance with the above, not less than \$10.00 and not more than \$100.00, or not less than ten and not more than thirty days' imprisonment.
