**DEPARTMENT OF LANDS AND MINES  
NOTICE  
Regulations Governing Angling on Waters  
Within Game Refuges.**

The following regulations regarding angling now applicable to the Lepreau, Becaguimec and Bantalor Game Refuges shall apply to the Restigouche and Camman River Game Refuges:—

- 1.—Permit shall be good only between May the 15th and August 31st inclusive.
- 2.—No fish less than eight (8) inches in length may be retained.
- 3.—Not more than thirty (30) fish shall be taken from the Refuge in any one trip.
- 4.—Fees. Residents \$1.00 for the season. Non-residents must pay regular fee at \$1.00 for trout license and must have a Woods Travel Permit.
- 5.—Any person violating any of the provisions of this regulation is liable to a penalty of not less than \$10.00 and not more than \$50.00 for each offence and in default of payment to imprisonment not exceeding one month.
