## Letters Patent

### "MONCTON CLUB, LIMITED"

Public Notice is hereby given that under "The New Brunswick Companies' Act" (being Chapter 88 of The Revised Statutes 1927) and amending Acts, Letters Patent have been issued under the seal of the Provincial Secretary-Treasurer of the Province of New Brunswick bearing date the Seventeenth day of October, A.D. 1932, incorporating: John L. MacDonald, Manufacturer; Amasa J. Tingley, Railway Official; R. P. Dickson, Merchant; Edward A. Cummings, Business Manager; Everett M. Smith, Business Manager; Reid McManus, Contractor; Stuart J. McLeod, Bank Manager; and Thomas J. Allen, Barrister; all of the City of Moncton, in the County of Westmorland and Province of New Brunswick; for the following purposes, namely:

To establish, maintain and conduct a club for the accommodation of members of the Company and their friends and to provide a Club House and other conveniences and generally to afford all members or their friends all the usual privileges, advantages, conveniences or accommodation of a Club.

Generally to purchase, take on lease or in exchange or otherwise acquire, any real or personal property and any right or privilege which the Company may think necessary or convenient for the purpose of the conduct of its affairs.

To construct, maintain or alter any
