#### LEGISLATIVE ASSEMBLY

### Rules and Practice Regarding Private Bills

The attention of parties intending to seek the passage of Private Bills at the next Session of the Legislative Assembly is directed to the following rules. 77. Private Bills shall be introduced on petition setting forth the nature and

objects of such Bill, and shall be accompanied by the prescribed evidence that the requirements of the three next suc-ceeding rules have been duly complied with, and also a certificate from the Deputy Provincial Treasurer that the fees applicable to such Bill have been received by him. Private Bills not intro-duced within ten days of the opening of the Session shall be subject to a fee on introduction of double the amount pro-vided for by Rule \$4, as also shall Bills in respect to which any of the Rules of

in respect to which any of the Rules of the House have been suspended to permit of their introduction. (No Bill can be read a second time until one hundred and fifty copies, prop-erly printed and folded, have been de-posited with the Clerk of the House). 78. No Private Bill, or Bill making any amendment of a like nature to a former Act, shall be received by the House, unless a notice, specifying clear-ly and distinctly the nature and objects thereof, has been published at least thereof, has been published at least once a week for three successive weeks previous to the meeting of the Legisla-ture, or to the introduction of the BiH, in some one of the newspapers published in the county interested in or to be affected by the measure, or in the locality where the parties affected, or the majority of them, reside; and when no news-paper is published in such county or locality, then in some newspaper having general circulation in such county locality, and also in the Royal Gazette. When the city or county interested in the measure, or in the locality in which the parties affected reside, is largely composed of a French population, then such notice shall also be published in a French newspaper, if any be published in the Province.

When any Bill affects civil or municipal interests, a notice distinctly specifying the purposes and objects of the Bill shall, at least one week before the introduction of such Bill into the House, be delivered to the Secretary-Treasurer of the County or to the Clerk of the City or Town which may be afof the City or Town which may be affected.

Proof that the requirements of the three last preceding Rules have been complied with, shall be by affidavit or statutory declaration, and it shall be the duty of all parties sceking to promote the passage of any private Bill to file with the Clerk of the House the evidence of such compliance. such compliance

such compliance. 83. In default of such proof or evi-dence being so furnished, it shall be the duty of the Clerk to report to Mr. Speaker, or the House and to endorse upon the Bill, that the Rules and Standing Orders have not been complied with. 84. No Private or Local Bill shall be received unless it shall be certified by the Deputy Provincial Treasurer upon the Bill, er by certificate annexed there-to, that there has been received into the

Provided, that when a Bill in respect of which such payment has been made, does not pass the Legislature, it may be introduced at the next following Session upon the payment of an additional sum of \$10.00.
