A Proclamation.

WHEREAS in consequence of the Demise of His late most sacred Majesty King George the Fourth: I have thought fit to dissolve the General Assembly of this Province, which now stands prorogued to the Tuesday in December next; I do for that purpose publish this Proclamation, and accordingly by these Presents do dissolve the said General Assembly; whereof all persons whom it may concern, will take due notice.

And I do hereby declare, that I have this day given orders that writs for calling a new General Assembly be issued in due form, the said writs to bear teste on Tuesday the fourteenth day of September, and be returnable on Monday the fifteenth day of November next.

Given under my Hand and Seal at Fredericton, the thirteenth day of September in the Year of our Lord, one thousand eight hundred and thirty, and in the First Year of His Majesty's Reign.

Public notice is hereby given, that the Disposal of Crown Lands in New-Brunswick, will hereafter be conducted in conformity with the following Regulations:— 1st.—Persons desirous of obtaining any quantity of Land, not exceeding 1200 Acres, will apply at the Office of the Commissioner of Crown Lands and Survey-General, where plans of the most eligible vacant tracts will be exhibited with the price attached to each Lot.
