Thus it appears that in the new colony, that Boards or Plank, if under the arecise article is wanted, of which we have an over supply ;) and to export our superfluous abour, by which the home market would be lieved, while the wants of the colony would he supplied, seems the most natural and obvious remedy for the existing evils. By diminishing the over-supply of labour, we raise wages ; we thus improve the condition of the labourer. and remove the severe evil of poverty which resses upon him. Butit is justly remarked by hr. Smith, that there is no article which is so expensive to remove from one place to another as man ; and hence the great difficulty of carrving emigration to such an extent as would Hud any perceptible relief to those who are left behind. No country was ever yet relievd by voluntary emigration, and the poor labourers, unless they receive public aid, will never he able to quit the overstocked market a which they are starving, for the better market of the new colony? An important question thus arises, namely, whether it is expedient to interfere, and to aid, by pecuniary advances, those in lividuals who are willing to seek, in a foreign land, an asylum from the evils which oppress them at home. The great difficulty would be in superintending the details on such a scheme, with that vigilance, sagacity and aution which would be necessary in order to
