By a last and secret article not inserted in the treaty, it has been agreed that the Porte shall not permit any foreign ships of war to enter the Dardanelles until after the conclusion of the arrangements resulting from the aforementioned articles. The latter article is said to have given great umbrage to the ministers. The Russian army is in full return from Constantinople.

Civil Appointments.

John Baillie to be Commissioner, in the room of Thomas Mesereau, to expend £100 granted in 1831 to build a bridge over the south branch bridge of the Oranoceto at the King's landing, also the sum of £50 granted at the last session of the Legislature for the like purpose. Henry Fisher and Israel Smith to expend the following sums, in the room of Henry Fisher and Jeremiah Smith: £15 for the road from the County line to the School House in New Maryland settlement, and £45 in aid of individual subscription to erect a bridge across Baker's mill stream, in the Parish of Fredericton.

By the recent arrivals at New York and Saint John, London and Liverpool papers were received to the 24th and 25th of June, since which the English Mail for July has reached us, bringing Falmouth dates to the 6th of that month; we are thereby enabled to present our readers with a variety of interesting extracts on European affairs. Amidst the great questions which still continue to occupy the attention of Parliament and their magnitude and importance to the British nation and her Colonial interests, it affords us great satisfaction to learn that the commerce of the country has assumed every appearance of an improvement. The causes says the London Price Current are various, the principal may be stated to be the long stagnation—the very depressed prices—the settlement of the Bank question—the prospect of a renewed circulation of paper by the Country Bankers, a great part of the most obnoxious part of Mr. Peel's Bill being removed by the making of the Bank of England note a legal tender, by every establishment, except the Bank itself and the branches of that Company. The settlement of all the threatening Foreign relations of the country has also given confidence to the Monied and Commercial interests.

THE LATE BRISTOL RIOTS.

Extract of a letter, dated Bristol, May 26, 1833. "I wish I could give you any local news that I thought would be interesting, but really I cannot think of any thing at present, except, indeed, that we are beginning to recover a little from the depression—or I should say the distress occasioned by the wretched affair of October 1831.—The houses in Queen Square are being fast rebuilt, and although the citizens are to be burthened with a "Compensation Tax" for eight years, trade is reviving, and peace and concord seems to have resumed their wonted way among us—aye and Whiggery and Radicalism are rapidly declining, so that we hope soon to be entitled to claim our ancient proud title of "Bristol the Loyal."

Spontaneous Combustion of Coals.—On Saturday afternoon, the Coals belonging to the New Brunswick Mining Company, deposited in a building on the Mill Bridge, were discovered to be on fire. An alarm was immediately sounded and exertions made to extinguish the fire. About midnight, however, it was discovered that the smothered embers had again ignited, and were burning fast. The coals were then removed; the floor of the building was also considerably burnt. The fire was produced by spontaneous combustion.—*Obsr.*

Remarkable Iceberg.—Several of the vessels from Great Britain which have arrived within the last few days, experienced strong contrary winds from the close of May to the 10th and 12th July, and were from 40 to 50 days in making the Banks of Newfoundland, where they fell in with icebergs of extraordinary size. One of the bergs seen on the 1st July, lat. 46, long. 49, was supposed ashore in 65 fathoms, and rose from 80 to 100 feet above the sea, being from two to three miles in circumference. By the operation of thawing and the undermining by the sea, immense masses of it were occasionally detached from the berg, with a noise like thunder, raising the water in the fall to a great height. Within a circuit of 50 to 100 miles from the berg, eight or ten pieces of 20 to 50 feet high, could always be seen from deck when the weather permitted a view of a mile or two round the ship. The weather was however, generally hazy; and in the night the ships avoided striking with difficulty, being only warned of their danger by the loud roar of the breakers on the ice.—*Quebec Gazette.*

Dublin, June 17.—The emigration from the North of Ireland, both to the United States and Canada, has taken place this year to a considerable extent through the port of Londonderry. A large portion of the emigrants to the States were respectable farmers, and fully three-fourths of the entire are Protestants. They are estimated by the editor of the Londonderry Sentinel, (who gives a list of vessels sailing with passengers,) as having emigrated from an adjoining district of forty miles square, and as having taken on an average only £10 each with them, (though some took very considerable sums.) They make the total sailed from Londonderry forty ships, 12,987 tons registered, having 6504 passengers. There only remain in port the brig Ann for Philadelphia, and ships Fort and Eweretta, for St. John, New-Brunswick, to sail the ensuing week. These vessels will, it is expected, have nearly their full complement. From all

that can be learned, double the number are preparing to leave the country next year, despairing of better times.
