HALIFAX, 9th April, 1834. THE Deputy Post Master General feels it to be a being read and the truth of the above allegaduty he owes to the Department under his charge, and to himself, to give publicity to the Court :- It is ordered pursuant to the Acts of following Letter from the Right Hon. the Secretary of State for the Colonies by His Honor the President, and communicated to him by command of His Honor.

[COPY.] DOWNING-STREET, 28th February, 1834.

HAVE had the honor to receive your Dispatch of the 17th of December last, accompanied by a Memorial from Messrs. Philip J. Holland and Edmund Ward, Publishers of Newspapers in Halifax, complaining of the exaction (illegal as they allege it to be) of Postage on Newspapers forwarded through the Post Office into the Country You will acquaint the Memorialists, that the practice of which they complain, is not illegal but is founded on an Act of Parliament, empowering the Post Master General to authorize certain of his Officers to circulate Newspapers by Post and it has been in existence since the first estab-Colony.
