MARRIAGE .- It was not until the Council of Treut, in 1429, that the intervention of a priest or other ecclesiastical functionary was deemed in Europe indispensable to a marriage. The celebrated decree passed in that session interdicted any marriage otherwise than in the presence of a priest, and at least two witnesses .---Before the time of Pope Innocent the Third (1198) there was no solenmization of marriage in the church, but the man came to the house where the woman resided, and took her home to his own, which was all the ceremony then used : hence the expression, "uxorem ducere et capere in virum." 
