## NEW BRUNSWICK IN CHANCERY.

Friday, November 28th, 1834.

Between Charles Connell junior, Complainant, and William Kirk, Defendant.

FORASMUCH as the Court was this present day informed by Mr. Fisher, being Plaintiff's Counsel, that the Plaintiff had on the eighteenth day of October last filed his Bill in this Honourable Court against the Defendant, as by the Certificate of the Register appears, and had taken out process of Subpoena against the said Defendant, returnable the eighteenth day of October last, but that the said Defendant now resides, and for a long time past hath resided, at Bangor, in the State of Maine, one of the United States of America, and out of the Jurisdiction of this Honourable Court, and that the said Defendant could not be duly served with such Process, all which by affidavit now read appears; and the said Certificate and Affidavit being read, and the truth of the above allegations being made out to the satisfaction of the Court: It is Ordered that the said Defendant William Kirk do appear to and answer the Plaintiff's Bill on or before the second Tuesday in March next.
