ARRANGEMENT OF THE CIRCUITS FOR THE YEAR.

The Hon. The Chief Justice—St. John, Tuesday, 16th June.

Mr. Justice Botsford—Charlotte, Tuesday, 4th Aug.; Carleton, Tuesday, 29th September; King's, Tuesday, 26th January, 1886.

Mr. Justice Carter—Sanbury, Tuesday, 17th February; Queen's, Tuesday, 24th February; Kent, Tuesday, 25th August; Westmorland, Tuesday, 1st September; Saint John, Tuesday, 12th January, 1886.

Mr. Justice Parker—King's, (Special Court of Oyer and Terminer) Monday, 2d March; Gloucester, Monday, 31st August; Northumberland, Tuesday, 8th September.

The following are the Terms upon which His Majesty's Government have authorized the granting of Leases to Owners of Lands in New Brunswick who may wish to work Coal situated beneath their own Property.

1. Leases may be granted for fifty years.
2. A Duty of \$s. N. B. Currency to be paid for every Chaldron of 72 Cwt., commonly called the Newcastle Chaldron, raised to the surface.
3. Payment of the Duty to be made every Six Months after the expiration of the first Twelve Months—that is, at the expiration of the first Year the duty on the Coal raised the first half Year to be paid, and every Six Months in succession the duty to be paid for the preceding half Year, thereby leaving the Lessee Six Months in arrear of Duty at every Payment.

4. At the expiration of the first Lease of a Mine, if the Government refuse to renew the lease, and if the Buildings and Machinery employed have been erected by the Lessee, the Government shall pay for them at a fair valuation to be determined by Arbitration. But if erected by the Government, or paid at the expiration of a previous Lease, any succeeding Lessee to be bound to deliver them up in good order and repair—and also be bound to deliver up all Shafts, Drifts, Drains and Workings in good order and well secured.

5. A clause of Forfeiture to be added to the preceding conditions, in the event of the Lessee omitting, for a specified period, to open a Mine on the property comprised in his Lease, or ceasing, for a specified period, to continue such Works as may have been commenced.

With respect to the encouragement of Trials to find deep Beds of Coal, no express stipulation can be made, nor any express remission of duty promised; but should the Government be satisfied that skill and activity have been exerted, and some risk encountered in opening successfully deeper Strata than previously worked, there will be every disposition to allow a liberal gratuity out of the amount of Royalty, which may become due on the produce of the new Mines; such gratuity, however, in no case to exceed half the outlay.
