MILITIA GENERAL ORDERS.
HEAD QUARTERS,
Fredericton, 17th March, 1835.

His Excellency the Lieutenant Governor and Commander in Chief, has been pleased to accept the resignation of the following Officers of Westmorland Militia, whose rank will cease from this date, viz:—

Lieut. Col. Philip Palmer, 8d Batt. Westmorland.
Lieut. T. Kiellor, 2d ditto.
Ensign James A. Black, 2d ditto.

Lieutenant Maxwell, of the Artillery Company, attached to the 4th Battalion Charlotte County Militia, is reinstated in his rank, &c. he having been superseded, in consequence of an error in the report of Lieut. Col. Mowat.

It having been reported to the Commander in Chief that Capt. N. J. Brown, of the Saint John City Rifle Battalion, has, by his irregular habits, rendered himself totally unfit to hold a Commission in the Militia of New Brunswick—His Excellency therefore directs that his Commission be cancelled, and that he cease to be an Officer in the Militia from this date.

His Excellency the Lieutenant Governor, having received His Majesty's Commands to resume the Collection of the Quit Rents in this Province, PUBLIC NOTICE is hereby given that these Orders are immediately to be carried into full effect; and all Persons owing Quit Rent are hereby required respectively, to pay the amount due since Midsummer, 1831, (the period to which His Majesty was pleased to remit them,) to the Receiver General at Fredericton, or to such Deputies as shall be appointed in the several Counties, on or before Midsummer next, or in default of so doing Legal Proceedings will be then instituted against them.

All Persons, however, who may be desirous of redeeming their Rents, will be permitted so to do, at Sixteen Years purchase, if the redemption money be paid on or before Midsummer, 1837—or at Eighteen Years purchase, if paid by Midsummer, 1839.

Persons not taking advantage of these periods will be required, after Midsummer, 1839, to pay Twenty Years purchase for the redemption.

NEW SYSTEM OF LICENSING TIMBER.
SYSTEM to be adopted in future in granting Licences to cut Timber on Crown Lands, to continue in force for Five Years.

1. The applicant to file a Petition agreeably to the form A.

2. The sum of One Pound for every square mile comprised within the bounds described in the Petition, to be paid when the Petition is filed, towards meeting the expense of the Survey—the same to be returned, with the exception of Five Shillings, if the Petition be not complied with; and the external lines of the Berth to be extended with all dispatch if the Petition be complied with—the Petitioner furnishing assistance, for which 5s. per diem will be allowed for each man, the remaining expenses of the Survey to be defrayed by the Crown.

3. In addition to the sum paid on filing the application, the rates of duty to be 2s. 6d. per ton, on Red Pine; 2s. per ton, on White Pine; 3s. 6d. per Thousand superficial Feet, on Mill Lumber; and 10 per cent. on the estimated value of all other descriptions of Lumber.

4. The applicant will be required to pay duty on a certain quantity of Timber or Lumber annually; such quantity to be named by the Commissioner of Crown Lands, according to the extent of the Berth, but in no case less than 60,000 feet of Lumber, or 200 tons of Timber; one fourth part of said duty to be paid on the 24th day of September, one fourth part on the 24th day of December, and the residue on the 24th day of June following, and on the last mentioned day he must produce a satisfactory account of the quantity of Timber and Lumber manufactured upon and removed from the said Berth up to that period, and pay up all arrearages of duty thereon.

5. The applicant will be allowed to resign his Berth on any 1st day of May, by giving

three months previous notice and producing certificates that the Timber is exhausted on the said Berth; or in case of the death of the Petitioner, or under any other special circumstances as may be approved of by the Lieutenant Governor.

6. Persons wishing to obtain smaller quantities of Timber or Lumber may take out Licences under the present Regulations, but subject to the advanced rates of duty.

7. Bonds, with one or two sufficient Sureties, to be taken for the payment of the duty, and for the due performance of the conditions of the Licence.

He pledges himself to keep a correct register of the Timber and Lumber obtained under the Licence now prayed for, and to exhibit the same to the proper Officer when required, and at the Crown Land Office annually, on the 24th day of June; and he will comply with all regulations to be observed by Persons cutting Timber or Lumber on Berths licensed to them in the manner now prayed for. REGULATIONS.

The within named _____ is required to pay duty at the Crown Land Office on _____ tons of White Pine Timber annually, at the rate of Two Shillings per ton, and in the following instalments, viz. the sum of _____ on the 24th day of September, the further sum of _____ on the 24th day of December in the same year, and the residue, being _____ on the 24th day of June in the following year, at which time and place he is required to exhibit an attested account, showing the total quantity of Timber and Lumber removed from the within described Berth during the preceding Twelve Months, and if he shall have removed a greater quantity than _____ tons of White Pine Timber, he will then there pay duty on such excess at the rate of 2s. 6d. per ton, for Red Pine Timber; 2s. per ton, for White Pine; 3s. 6d. per thousand feet, for Mill Lumber; and 10 per cent. on the current value of all other descriptions of Lumber in the market.

2. He is required to mark on each stick its number and contents, and to keep a register of the same in the camp; which register must be produced when required by any Seizing Officer, duly qualified; and he must also mark each stick as follows _____; such mark to be distinctly placed within triangles

on three sides of the stick, near both ends, and all private marks must be placed near the centre of the stick.

3. He will be allowed to resign this Licence at the expiration of any one year, by giving three months previous notice and producing a certificate that the Timber is exhausted.

4. He must in all cases give Bonds, with one or two Sureties, to the King, for the payment of the duty and the faithful performance of all the conditions of the Licence.

5. He will be required to state on the 1st day of May, the quantity he intends cutting in that year, and pay duty accordingly; but he will be allowed to correct the quantity applied for within the year, and pay up the balance of tonnage, but in no case is the Timber to be cut before applying and paying instalments for the same.

N. B.—As much good would result from a uniformity of Surveying the Berths, Petitioners should, as much as possible, describe the Tracts they wish to occupy, by lines running north and south—east and west.
