THE LIVE STOCK recently imported from London at the expense of the Province, were sold at Public Auction in this City on Wednesday last according to advertisement. They were purchased by Agricultural Gentlemen from different parts of the Province, and, generally, at low prices, having suffered considerably in appearance, from the effects of a tedious sea voyage. One of the Marets, a fine looking and valuable animal, brought £62.

Mr. John Howe, Jun. son of the Deputy Postmaster General of Nova Scotia and New Brunswick, has been appointed to the office of Postmaster in this City, vacant by the death of Charles Drury, Esquire.

Robert Carter, Esquire, Commissioner from the Court of Directors of the Bank of British North America, established in London, with a capital of one million sterling, visited this town on Wednesday last, and had an interview with our capitalists, when arrangements were made for establishing a Branch here, which we understand will go into operation on the first of March next; and which will bring into circulation in addition to the amount now employed, thirty thousand pounds sterling.

An advertisement relative to the Charlotte County Bank will be found in our columns, which arises from a conviction on the part of those interested in the welfare of that institution as well as of the Country, generally, that two Banking establishments in Saint Andrews would only produce inconvenience to each other, while it is allowed by all that a larger Banking Capital is absolutely necessary to meet the legitimate mercantile demand, and it is consequently considered advisable to accept of the North American Bank, permitting the Stockholders in the Charlotte County Bank to invest in the new Establishment if they feel so disposed; an arrangement we believe will be made by some of the Stockholders, friendly to the measure, to purchase any stock of the C.
