A PROCLAMATION.

WHEREAS in consequence of the Demise of his late most sacred Majesty King William the Fourth, the General Assembly of this Province, which now stands prorogued to the Third Tuesday in September next, is dissolved, I do therefore publish this Proclamation declaring the said dissolution, whereof all persons whom it may concern will take due notice.

And I do hereby declare that I have this day ordered Writs for calling a new General Assembly to be issued in due form, to bear Teste on Thursday the twenty fourth day of August instant, and be returnable on Monday the sixteenth day of October next.

Given under my Hand and Seal at Fredericton, the eighteenth day of August in the Year of our Lord one thousand eight hundred and thirty seven, and in the first Year of Her Majesty's Reign.

His Excellency the Lieutenant Governor having been pleased to constitute a Board for auditing all the public accounts of the Province, and to appoint the Honorable Frederick P. Robinson, Auditor General, and Henry G. Clopper, Esquire, Assistant Auditor, the Supervisors of Great Roads, the Commissioners of Bye Roads, and all other persons intrusted with the expenditure of public money, are hereby required to transmit their accounts, with proper vouchers, to that Board at as early a period as practicable after the performance of the work.

By Order of His Excellency.

Ordered, That all Persons in the Offices of the Land granting Departments, be positively prohibited from being themselves directly or indirectly parties to or concerned as agents in the purchase or acquisition by Sale, Grant, Licence or otherwise, of any ungranted Lands of the Crown, without permission from His Excellency the Lieutenant Governor in Council.
