### TOWN COUNCIL.

Business Meeting Held Last Evening.

### RESERVOIR MATTER.

Council is now in Favor of Settlement Without Arbitrators.

The Town Council met for business last night. Those present were: His Worship Mayor Murray, and Couns. Blackhall, Blair, Joudry, Laughlan, Taylor and Vantour.

Minutes of last meeting read and confirmed.

Clerk read communication from Jackson Miller asking for increase of pay. Referred to Police and License Committee.

Report of Auditors of Board of School Trustees was read.

Clerk also read a communication from A. Lacasse asking for transfer of his pool table license to Robert B. McIntosh, who has purchased that branch of his business. Transfer granted.

Coun. Blackhall, Chairman of the Finance Committee, submitted a report recommending the payment of the following accounts:—

Coun. Laughlan, of the Electric Light Committee, read report and recommended the payment of the following accounts:—

Report received and adopted.

Account of Messrs Murray and McLatchy for \$174.12 for services rendered referred to Finance Committee who were empowered to employ Mr W. A. Mott to ascertain the town's liability in the matter.

Coun. Taylor, Chairman of the Special Arbitration Committee, submitted report. His committee had seen Robt S. Duncan and had obtained from him the lowest figure at which he would settle the reservoir matter. Three thousand two hundred and fifty dollars is the price now asked by Mr. Duncan.

Coun. Blair said he was in favor of paying Mr. Duncan \$3,250 for the land at reservoir. It would be the cheapest and best way out of the matter. He explained the cost of arbitration.

Coun. Vantour was of the opinion that it would be well for the town to settle at the sum named by Mr. Duncan. He thought the sum was large but the cost of arbitration would be larger.

Coun. Blackhall said that this matter had been forced upon the town by bad legal advice and he would like to see all the Council present before a final settlement was made.

Coun. Joudry asked if it would not be advisable to take a vote of the ratepayers on the matter.

Coun. Blackhall thought that if it would not cost much to take the vote of the ratepayers it would be advisable to do so for then the Council would have the voice of the people in the matter.

Matter of insurance on town buildings was discussed. Coun. Taylor was in favor of increased insurance.

Coun. Laughlan chairman of the Electric light committee said that the roof of the power house over the engines and dynamos was in bad condition and suggested that the metal roofing be taken off, roof boarded in and metal roofing replaced. They had under consideration the raising of the small boiler at the power house, also the placing of an arc lamp on Bay View Avenue and would like to have the voice of council in these matters.

The Mayor suggested that Coun. Laughlan submit improvements in writing.

Council adjourned until Thursday evening 7th inst.

### BIG GAME SEASON

Preparations for Opening of Season

### MOOSE PLENTIFUL

Thought Season will be a Record one. Many Sportsmen

The season for big game shooting opens on Friday, Sept. 15th. Already parties are making preparations to go to the woods, and many have written to guides making dates for September and October.

The open season for all kinds of game is as follows:

Moose, Caribou, Deer, Sept. 15 to Nov. 30

Geese, Brant, Ducks: Sept 1 to Nov. 20

Snipe and Woodchuck. Sept 1 to Nov 30

Partridge, Sept. 1 to Nov. 30

Already a number of local sportsmen are making preparations for their annual hunt for big game, and several parties will probably be on the ground for the opening of the season.

All indications point to a successful season. Sportsmen say that during the forenoon lately large numbers of moose were seen along the track, while reports from the game districts say that big game is very plentiful, giving promise of a record season.

### BRITAIN AND JAPAN.

The Scope Of the New Alliance Much Broader Than Under Old Treaty

London Sept. 7.—The conclusion of the new Anglo-Japanese treaty of alliance which the associated press announced on Aug. 25 had been signed, has only now become definitely known to the English newspapers, which are keenly interested in it and are anxiously discussing its probable contents.

An important modification binding either power to come to the assistance of the other if attacked by one, instead as in the old treaty, by two powers, causes disquietude in some quarters where it is thought to add enormously to Great Britain's responsibility; but on the whole complete satisfaction is expressed as to the scope of the new treaty, as far as it is at present known.

The daily Telegraph representing the views of the government and well reflected the opinions of a majority of the newspapers in an editorial says:

The Anglo-Japanese treaty will guarantee the terms of the Portsmouth treaty. It will check any insane idea of Russian revanche, will render impossible an anti-Japanese coalition and effectually terminate the scramble for China.

### FOR GOVERNORSHIP

Rumor that Premier Will be Next Governor

### TWO NEW SENATORS

Governor Snowball said to be one of the Candidates.

The St John Sun publishes the following: In connection with the two vacant senatorships in the province, it is regarded in well informed liberal circles as certain that one of them will go to O. J. LeBlanc, the federal member for Kent. Hon John Costigan has renounced his claims, in view of the fact that he is pretty well provided for by the act which gives to all ex-cabinet ministers who have served five years in office an allowance of \$3,500 per year.

For the other senatorship, the aspirants whose chances are regarded as being the best are Governor Snowball, whose gubernatorial term expires shortly, and Hon. H. A. McKown of St John. Other candidates for the position whose names are freely mentioned are A. Gibson ex-M. P., and D. Gilmour of Montreal and St George.

It is understood that Governor Snowball has the support of Premier Tweedie and Attorney General Pugsley, the idea being that in the event of Governor Snowball securing the seat in the red chamber that Hon. Mr. Tweedie will become lieutenant governor and Attorney General is called upon to form a government, it is believed that an appeal will be made to the province.

In the event of Mr LeBlanc being appointed to the senate, the liberal nomination for Kent would be believed, go to either James Barnes, M. P. P. or J. D. Irving.
