Vancouver, Friday.—Two gentlemen who came to Vancouver with the intention of making complaints of the timber business, are at present trying to adjust recent experiences of justice as she is administered in British Columbia with preconceived notions of Canadian and British fair play. JAP SITUATION IS BECOMING VERY SERIOUS SENDS MONCTON CONSTABLE UP FOR TRIAL

MONCTON, Friday.—Constable Charles H. Thomas was this morning sent up on trial on the charge of theft. Magistrate Kay on committing him commented scathingly on what he termed the Shylock methods of Moncton constables in securing money. Noble Steeves gave Thomas two twenty dollar notes on which to raise money on the understanding that Thomas was to return Steeves ten dollars and one of the notes. Thomas told the magistrate that he had secured only five dollars on one note and had turned up the other. Later Steeves was captured by Constable Dryden, Mr. C. R. police officer, and made to pay both notes. Constable Thomas on the stand this morning admitted to securing fourteen dollars from Dryden on the note, but gave Steeves none of the money.

(Vancouver World.) Lethbridge, Dec. 26.—The interior of the Columbia Restaurant was partially wrecked last night and the windows of nearly every other Chinese restaurant were smashed by a mob of several hundred persons. The affair took place about midnight and the front of the Alberta restaurant and Joe Fong's were assailed at the same time. Constable Rose telephoned for the mounted police, a number of whom promptly arrived, cleared the premises and arrested several of the mob, but not until a Chinaman or two had been roughly handled. A police patrol cleared the street and went down to protect Quong Wong's place near the post office. Meanwhile a portion of the mob slipped round to the Barons Road and smashed the front of a Chinese restaurant near the Arlington. The mounted police came over and in a few minutes nothing was to be seen of any mob.

Shopsy after seven o'clock last night the rumor that Harry Smith, a well-known and popular rancher from Little Bow had died at the hospital from the effects of a blow with a hammer struck by a Chinaman in Columbia restaurant was started. As a matter of fact, Harry Smith was quite well and enjoying a social evening with a Christmas party. This fact was not known, however, and the rumor was believed. The Chinaman who had struck him was arrested and put in jail, but this fact was also unknown, and an indignant angry mob gathered in front of the restaurant and there was talk of a lynching. Doors were burst open, counters and tables were turned and any Chinaman who could be caught was roughly treated. Simultaneously a portion of the crowd smashed the windows of neighboring Chinese restaurants. No goods were taken and the shelves were undisturbed at the restaurants. Beyond breaking the windows but little actual damage was done though a number of badly scared Chinamen fled wildly to cover.

Mayor Galbraith was early on the scene and called on the good citizens to disperse and go to their homes. Magistrate Humphreys, when a portion of the crowd visited the Quon Sang restaurant on Ford street, persuaded those on evil bent that Quon Sang had ever been a good citizen and that he had never given any trouble, and the mob acting on his advice dispersed.

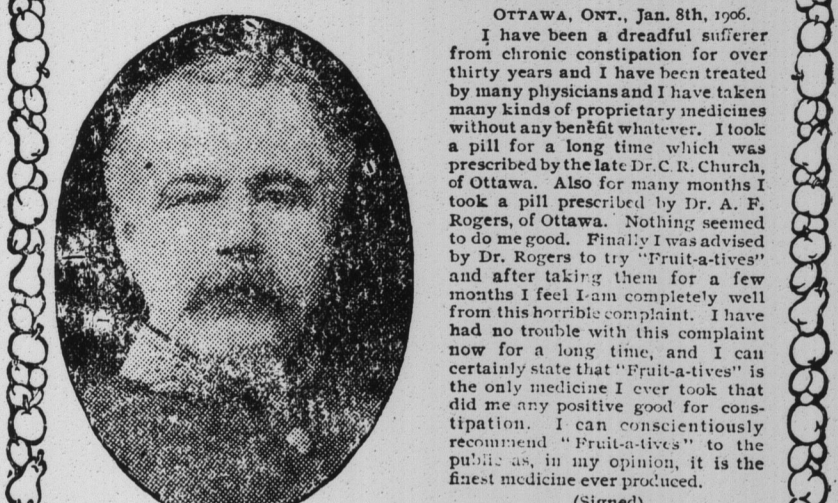

WESTMORLAND HAS END OF FAMOUS A STRONG TORY CASE REACHED TICKET SATURDAY

MONCTON, Saturday.—The city is said to be dry, but as a matter of fact, several fire alarms have been rung lately but nothing will burn. So the city is not so dry after all. The authorities, or rather the chief of police and his coterie of officers mean business now and have begun the search for the ardent, and if they are as successful as some of those who see on our streets some nights, who feel its "staggering" blow the "dunce" will be to pay before long.

The conservative convention this afternoon at Sackville nominated F. W. Sumner of Moncton, F. Black, Sackville, O. M. Melanson, Shediac and P. Mahoney of Beaufort, as good as could be secured with one exception. Had Mr. Humphreys' name appeared on the ticket it would mean 100 more votes and even then they would have as many as the government ticket except about a thousand. One of the silliest canvasses I ever heard of is that the road act was responsible for the bad state of the roads last summer and autumn months. The weather during the said period, we all know has been such that the hay and grain could not all be gathered. The rain nearly every day made it literally impossible for any one to do any work on the roads, either to repair or make new roads. During the soft weather just before the ground froze up, there was a foot of mud on St. George St. It was almost impossible to cross the street. It is just as reasonable to blame the road act and government for the bad state of St. George St. in the city of Moncton as to blame them for the condition of the roads in the country during the worst season that has ever visited us within the recollection of the oldest residents.

Such nonsense will not carry—and anyway the opposition had the opportunity of opposing the new road act but did not do so. My opinion is that the law was all right and, if properly enforced, is one of the best laws we have had for years.

One of the constables here was committed for trial yesterday on a serious charge, and given a good dressing down by Judge Kay who never misses an opportunity of giving wholesome and timely advice, sometimes accompanied by opportune sarcasm. C. H. Thomas met Noble Steeves from Salisbury and both wanted money. Thomas did the planning. He was to do the work and do Steeves too. He took two notes from Steeves in his name, \$20 each, one payable in Moncton, the other wherever he could get the cash. If the Moncton note did not bring, Thomas was to get \$20 on one and give Mr. Steeves \$10 and the other note. He gave Steeves \$5 and said he destroyed the other note. Dryden another constable cashed the notes and capased Steeves for the \$40 which he paid pending action.

TORONTO WILL HONOR HANLAN

TORONTO, Saturday.—The late Edward Hanlon will be honored in death by the city to which he brought more honor and fame than perhaps any other citizen the city has ever known. The mayor and the board of control this morning decided to have a public funeral as a last token of the appreciation of the citizens for the man who first carried the name "Toronto" into the world.
