F. C. Baptist Conference.

The F. C. Baptist conference, which has been in session at Marysville for some time, completed its labors Wednesday. The business transacted the last day was of importance. The report of committees on the general secretary's report was first taken up. It recommends the appointment of Dr. McLeod as general secretary to do the following things: To prepare plan for a better circuit system, also a plan by which supplemental funds can be raised, to aid poor pastors and prepare more systematic methods of increasing the ministers' relief fund. The report was adopted.

A resolution was passed authorizing Dr. McLeod to enter upon the work of soliciting aid for the Union Baptist seminary.

The report of the auditor, hon. George E. Foster, accounts, showed the balances on hand were: Treasurer of conference, \$125.82; treasurer of ministers' relief fund, \$153.22; board of managers, \$4,906.48.

A resolution was passed endorsing Rev. Wm. Doan as evangelist.

A committee was appointed consisting of Revs. A. C. Thompson, G. A. Hartley, Dr. McLeod, J. W. Clarke and C. T. Phillips to confer with like committees of the Nova Scotia and Maine conferences with a view to a closer union.

The conference went into committee of the whole to examine licentiate and afterwards reported that D. Long, R. W. Carter and Abraham Perry be ordained and that conference licentiate be granted to W. R. Rend, F. Currier, S. J. Peroy, A. W. Cursey and J. Harvey. The appointment of directors of the Union Baptist seminary was referred to the executive committee.

Conference closed with prayer by Dr. McLeod.

In the evening the church at Marysville was crowded beyond seating capacity on the occasion of the examination of Messrs. Long, Carpenter and Perry. Rev. G. A. Hartley questioned the candidates. The right hand of fellowship was given by the moderator, Rev. A. C. Thompson. The church funds and offerings were given by Rev. C. T. Phillips and the ordination sermon was preached by Rev. J. T. Parsons.

Stanley Fair.

The Stanley fair was held on the exhibition grounds at that place on Tuesday last. There was a large attendance from this city and the several parishes of the county, and the exhibits in various departments were very creditable. The horse display was an excellent one, some nice colts exhibited. The root exhibit was a fine feature, that of John Thomas being particularly fine. The grain and fruit that was exhibited was above the average, but of the former there was a very small quantity. The two hotels, McMillan's and Turnbull's, were crowded and the stables were not able to accommodate one half of the horses. The show was a good one in every respect, sustaining Stanley's reputation, so widely known, of making everyone at home when visiting their fair, and besting what was said that flourishing section of the county can produce from its soil, its dairy, its farm house, etc., a good time always be spent among her quiet and hospitable residents, and it will be a visit that will always be remembered. In the evening the young people held a dance in the hall which was largely attended.

There were besides Chas. E. Sanford, of St. John, who was too young to be sworn in this term, but who will come up in Hilary, 1892, and Mr. Taylor, of Belvidere, N. W. T. who was sworn in on Friday morning. Geo. J. Wilson, B. A., who studied with Wm. Wilson, M.P.P., was most successful, having passed a highly creditable examination, and stands in the first place among the nine who have the very best chances and our best wishes for his future success, wherever he may be situated.

The proprietor of the Gleaner does not appear to be paying his assistants as promptly as they seem to desire. At the police court on Wednesday last, before John L. Marsh, Esq., P. M., W. G. McFarlane, until recently on the editorial staff of the paper, recovered a judgment for the sum of thirty-five dollars and ninety cents against James H. Crockett for services rendered by Mr. McFarlane as a reporter on the Ottawa. At this writing it is not known whether or not Mr. Crockett has "paid up and looked pleasant."

THE LOYAL "SCRAP"

To this Completion Faith is Come at Last.

The city has been greatly entertained during the last week by the incidents connected with the quarrel between two comparatively well known citizens.

The two citizens are J. H. Crockett, son of the ex-chief superintendent of education, and the recognized proprietor of the Gleaner newspaper, publishing a daily and weekly edition, and G. F. Gregory, Q. C., of whom many of our readers have heard as a frequent candidate at elections, in which he has not hitherto been remarkably successful.

These two persons are known to have been very fast friends - have had their knife in the hand, and were together some time past, and have been pulling together very heartily since March, 1887.

J. H. Crockett, whose version of the trouble we have heard, states the case fairly enough, and we think from what others have accurately heard, and we therefore furnish his statement as we understand he has been making it known to his friends.

It appears that Mr. Gregory, ever since March, 1887, when the resignation of the local government was withdrawn from the Gleaner, has been rendering pecuniary assistance to the paper, not only by way of advancing funds from time to time, but by way of numerous and frequent doctor's fees. These endorsements have become more numerous as the newspaper venture went into deeper water, and the bank naturally felt averse to enlarging and even perhaps continuing the accommodation. When, therefore, the other day one of the banks called for payment of a note of Mr. Crockett's, indorsed by Mr. Gregory, at maturity, the financial crisis arrived. Mr. Gregory, of course, had nothing else to do but finance all the paper out of the banks upon which his name was indorsed, and to do that, happily, funds were advanced to him by Mr. Crockett and his brother, the doctor, were willing to give the estate of Mr. Anderson, represented by Mr. Gregory as the executor, a very solemn promise that they would pay back to the bank the money that had to be borrowed to meet the numerous obligations, and, therefore, Mr. Crockett and his brother, the doctor, signed and sealed their bond to repay the \$4,000, in the above named elections, in which, as soon as the solemnities connected with the execution of the bond were over and the various bills distributed among the banks withdrawn and retired, then the executor of the Anderson estate had his attention getting some security for the amount of the bond, and Mr. Crockett was called upon by the executor of the said estate to make his little bill of sale to the executor, and the doctor, and to sign, with its stock and plant, office furniture, machinery, etc., and also the household furniture, kitchen utensils, bed, bedding, crockery, etc.

Mr. Crockett felt that the demand was an unreasonable one. The executor of the Anderson estate had already his bond to which he had affixed his seal, and the doctor's bond to which he had also affixed his seal in the presence of witnesses, and it appeared rather an outrage to the editor and proprietor that he should be asked to put his paper under the control of the executor of the Anderson estate and to give him any more authority than was already existing in connection with the policy and conduct of the daily and weekly edition. He therefore did not sign the document which had been drawn up for him, and the bill of sale submitted to him for execution by the executor, took it away for examination and it appeared a very useful purpose because it only required to be copied and a change in the names to answer for any other party.

The editor feeling that something must be done to safeguard the interests of his brother and doctor, and prevent the financial crash and ruin which would result three years hence from the enforcement of his bond, if it should happen that it was not convenient at that time to repay the \$4,000 and interest, immediately took with him to St. John street to consult with the counsel learned in the law, and that the bill of sale was given to the Dr. and not to the executor, and this bill of sale in terms most completely transferred by way of security not only the daily but the weekly edition with all the plant and paraphernalia to the doctor to secure the doctor against any loss or damage which would occur to him if he were called upon to pay the \$4,000 bond, and the doctor, at all events, for a long period of years as it was said, no rent had been paid by the editor, and so that security should be offered to the landlady for his rent, a second bill of sale was drawn up with great care, and with the operation of this second bill of sale, the furniture, kitchen utensils, bed, bedding, crockery, chairs, tables, shovels and long, etc., were conveyed and assigned to Mr. Vredenburg for \$1,500. These two separate bills of sale were forthwith recorded, and when the editor and executor met after the recording of these bills of sale became known, the doctor was very reprehensible. The editor says he was most wrongly accused by the executor, that when the executor charged him with having made a bill of himself and of having deceived him (the executor) at the last dominion election by deserting the liberal party and turning his paper into a conservative campaign sheet, and himself going to Harvey and there canvassing for the Tory candidate, that he was unjustly accusing him, or, at all events, that the charge was not one which he the executor ought to make, that he was the last man that should have thrown up to him what he did in connection with that election. The editor emphatically stated that from the best information we can gather we think he is correct in this, that he did not move a hand or foot or take any step except on the advice of the counsel learned in the law, and that it is in the direction of the executor, and that it is the duty of the executor to attempt to turn the tables on him in that way. He says that he told the executor that he had deserted the government, and that he was in his interests and support, and that he ought to be the last man to push him to the wall.

"Why, as you know, Gregory, I would have been in a sound financial position and my paper would have been on a solid basis to-day if I had stuck to Blair; I have stuck to you and see where I am."

"Well," says the executor, "if you did, you did not do it for me, you did it for yourself. You know that you were not satisfied with the way Blair was treating you. He never consulted you about anything, never advised with you as to what the policy of the government should be and, besides, that you were being slighted, you wanted to revenge yourself on him as well as I did."

"It is not so," says the editor. "It was you that first got me in a crack with him, and has been following you right along that has brought me to my ruin; it was following you that lost my father the chief superintendency of education and drove him out of the province."

"This false," says the executor, "I had nothing to do with your father's opposing the government - I did not ask him to vote against the government. When he did it, he did it of his own motion. I would have given up elections long ago, only to try and help you to recover your lost ground and get you back the patronage, and this is all the thanks I am getting for it."

"Do not undertake to tell me that," says the editor. "You would have given up elections and politics with a vengeance. You have been so determined to prosecute Blair to death, that you would sacrifice yourself rather than let me make the effort to sacrifice him. I would have gone back with Blair within six months after our first quarrel, but you would not let me. Richard Bellamy and Dr. McLeod wanted me to settle up the trouble and I was willing to try to

course Blair was obstinate, but I think that Dr. Moore and Bellamy could have accomplished it, but you would not allow the thing to be done, and now you want to get me under your thumb with a bill of sale, but you have not done it. I am going to pay you every dollar of your demand, the estate shall not lose a dollar. I shall, if it is necessary, issue an enlarged daily edition and increase the staff, get telegraphic dispatches, in fact infuse fresh life and vigor into the paper, now that I feel free. I am feeling a great deal better than I felt for the last four years since you got me under your thumb, and now I am done with you."

"No, you are not," says the executor, "you are not quite done with me yet, nor will I be done with you, until I have filled a bill in equity to expose your fraud. You owe me between \$5,000 and \$6,000, and you got \$2,300 from me when I settled with Mr. Dever, and I endorsed notes for you for \$2,800 more; so now, give me the bill of sale or take the consequences!"

"Very good, Mr. G," says the editor, "you may go on and do your best. Good-day, sir."

And so it appears the couple parted, each his own way, leaving a deep, wide chasm an impassable gulch between them. Thus it is always when men allow their vengeful feelings to guide their actions and destroy their judgment, and their common sense, that the editor should now be thrown over by the executor and left to finance for himself.

One is forcibly reminded of the words of David Copperfield, and they may well have come into the mind of the editor as he was bidding adieu for the last time on the threshold of the executor's Queen street office, "If I had but served my God as faithfully as I have served you, He would give me now desert me in this hour of my financial distress."
