As far as the casual observer can see, everybody is good natured, and peace reigns. However, hard work is being done by both sides in a fight to the finish. Government supporters are most enthusiastic and confident in their assertions that York will stand for Blair and his ticket by a very large majority. One enthusiastic supporter of Blair says that he has fifty dollars even, that the lowest government candidate will lead the highest opposition man by five hundred votes.

The usual war of words is taking place at the different polling places, and the cash is being hurled at many a doubtful voter. As the day grows the excitement increases, and before night it will have reached a fever heat. The general opinion is that York will stand government by a good show majority.

At the University.

The Y. M. C. A., assisted by the lady students of the college, tendered a reception to the freshmen class in the college library on Tuesday evening last. The freshmen were the favored ones of the evening, attention being done to them with a special view to making the occasion pleasant for them. A banquet was provided for each of them, and as they entered were graciously presented with the same by Miss MacLeod.

A fine musical program was provided by Mrs. Dr. Bridges, Miss Harrison, Mrs. Stockley, professors Duff, Stockley and Dixon, which ended with a chorus by the students. During an intermission in the singing, refreshments, consisting of coffee, cake, ice cream and fruit were served. The time passed rapidly, the general verdict being, that the reception was the best of the kind yet given.

Rugby football is receiving a good deal of attention from the boys at present. Last year the old association football game was given up and Rugby introduced in its stead. Agricultural.

The farmer and dairyman's association of New Brunswick will hold their annual meeting in Fredericton on the 25th, 26th and 27th January, 1893. Owing to the impetus given to this industry by the grant of the local government last session, and the increased interest taken in dairying throughout the province, a large and successful meeting is anticipated.

W. W. Hubbard, well known in agricultural circles, is on a tour through York county, having charge of travelling dairy. This is part of the plan adopted by the local government, to assist and awaken an interest in the dairying industry in this province. Mr. Hubbard intends to visit Upper Kewick Ridge on the 24th inst., Springfield on the 25th, Hayesville on the 26th, Upper Coverhill on the 27th, Temperance Vale on the 28th and Campbell Settlement on the 29th. It is expected that the other government lecturers on dairying will be doing the same in their respective districts during the winter.

THE SILENT MESSENGER

Softly Steals Among Those Whom We Record Below.

At Kincaird, on the fourteenth instant, John Roe, late of Nottingham, England, passed away in his sixtieth year. On Sunday last the late resident old child of Murray McDonald, of Marystown, was buried at sunny bank, Gibson. There was a large funeral. Albert Carson, of Tay Creek, died on Tuesday, the 11th inst., and was buried in the old burying ground at that place the following Thursday. His wife and three children have the sympathy of the entire community. Mrs. McInnis, widow of the late John McInnis, formerly a resident of this city, but now of Boston, died in that city suddenly of heart failure. Deceased was the daughter of the late William McInnis, and was between fifty and sixty years of age. Miss Lizzie Sloan, lately of this city, and at one time in charge of the stamp department of the post office, died at Moncton on Saturday, the 10th inst. For some time past, she was seized with fever, which ultimately resulted in her death. On Thursday morning, the 8th inst., after a protracted illness, between the hours of three and four, at the residence of Miss Maggie Moffat, Kingsclear, Maud S. Nicholson departed this life in the twenty-third year of her age. The faith she professed did not leave her in a dying moment, which was a consolation to her many friends. The Rev. Mr. LePage preached the funeral sermon from a portion of the nineteenth psalm.

Mrs. Wood, wife of Capt. C. A. Wood, formerly of this city, died in Boston last Saturday. The deceased lady had many friends in Fredericton. She was a sister of the late Mrs. G. T. Whelpley and Mrs. Capt. Richard of California, and was a daughter of the late John J. Mayes of Hampstead, Queens county, and leaves a sorrowing husband, one son, and one daughter. The remains arrived here Monday, and were interred in Forest cemetery. Capt. Wood, his son, Dr. Dow Wood, and Miss Laura Wood, who accompanied the remains from Boston to their last resting place, were in the company of this community in their great loss.

Dr. Connell, Woodstock's foremost physician, passed to his last rest on the morning of the 20th inst. For some time past he had been troubled with heart disease, but no serious results were expected. His sudden death cast a gloom over the town in which he had spent so many years of his life. The deceased gentleman was held in high esteem by his native townsmen, and was looked upon as a physician and honored him as an upright man. Mr. Connell was in his fifty-fourth year when he died. He was a member of the medical profession, and was a brother of Geo. H. Connell, who was elected to the house of commons in 1878, and who died suddenly at Ottawa, February 10th, 1881. He was born and brought up in Woodstock, and he had completed his education and his professional training, entered into medical practice there. Dr. Connell was one of the most genial of men. His hospitality, like that of other members of the family, was well known throughout the region around about. He was the soul of generosity and kindness. He was incapable of anything mean or dishonorable; he was in short a gentleman of the old school, without the old school failings and vices. The tidings that Chas. E. Murray had died on Wednesday afternoon at 1:30 o'clock was heard here with much sorrow. As announced in our last issue he had been severely injured on Friday evening, the 14th inst., by a loaded truck wagon passing over him, but hope was strong that being of a good constitution he would recover. It was not to be and a man who might call every resident of this city and county a friend, has passed away. Deceased was a man who took great pleasure in his work as a farmer. He was a practical agriculturist and district agricultural society, No. 24, conferred an honor on itself when Mr. Murray became its president. All will remember the active part he took in the affairs of the late provincial exhibition, and much of its success must be attributed to his energy and enterprise. His home above Springfield was one of the most beautiful in the county and his farm was a credit to his parish. Deceased, who never married, was a brother of William, Sidney and Rainsford Murray. The funeral took place yesterday afternoon; it was very largely attended, a great many from town going. It is said to have been the largest funeral ever held in Kingsclear. The remains were interred in the burying ground next the Episcopalian church. Messrs. Roberts and Montgomery conducted a most impressive service.

A SAD SCANDAL

OTAWA, Oct. 19.-The wife of a prominent Presbyterian divine here, a leading merchant of the city, now in Europe, and a broken-hearted husband, are the central figures in a scandal which has thrown the entire city into commotion. During the absence of the lady in question in New York, the matter was taken up by the board of session of the church, and the husband, who was present, completely broke down at the exposure of his wife's misdoings. When the woman returned from New York she denied everything except that she had been indiscreet. She has however, left Ottawa, taking with her her three-year-old daughter, and is now in New York. The husband will, it is said, throw up his city church here and seek a new home where his misdoings will not be known of.

THE MURDER.

Dr. Mullen, Peter Hughes, and Wm. Atkinson give Testimony. The murder case was resumed on Thursday morning, when Dr. Mullen was called to the witness stand. He said: Am a doctor of medicine and reside at St. Marys; I was called to the residence of the late Mrs. Estabrook's when first heard the noise; did not see Atkinson when Titus was shot. William Atkinson sworn: Reside at St. Marys; saw Titus and Atkinson in the street talking between 7 and 8 o'clock, there were others with them; then went home, came out again between 8 and 9; saw Atkinson striking Othello one on each side of the head; Atkinson said to Michael, 'you struck me and I have got it in for you'; didn't see Titus at that time, but as soon as Atkinson spoke heard glass break; Atkinson then left the door, and I saw Titus and his gun past Staples' window, which was lit up, and dodge into the alley; someone, whether the prisoner or not, threw something at the door, which appeared by the noise to be bottles; heard Othello say to Charles, 'fetch out the gun'; saw him go in for the gun and bring it out; saw Titus come out of the alley, going towards Michael's shop; saw the flash of the gun and saw Titus fall; did not see anything peculiar in his manner; when about 12 or 15 feet from the shop Titus fell; could not see who fired the gun; went to where Titus was lying; thought Atkinson was in the alley when Titus was shot; heard Othello say, 'd-m him, I would shoot the Queen if she interfered with my' coming past where Titus lay, he said, 'let him lay there and die.' To Mr. McCready: After the shooting witness met Alex. Atkinson on the street and started him up street. To Mr. Hughes: Was at the opposite side of street when I saw Atkinson talking to Othello; about a minute after this heard the glass break; Atkinson was in the alley with the door, and I saw Titus and Charles; saw Charles Michael come out with the gun and heard the shot almost immediately after; Atkinson tried to come out of the alley but Titus pulled him back after the breaking of the glass. Peter Hughes, the next witness, said: Was in prisoner's shop about three o'clock on the day of the shooting; saw Titus over the prisoner's counter; saw Charles Michael; he and the boy had a wrestle, that the boy threw him; Othello said the boy was only seventeen years old but was quite a good wrestler; saw the flash of the gun and saw Titus fall; did not see anything peculiar in his manner; when about 12 or 15 feet from the shop Titus fell; could not see who fired the gun; went to where Titus was lying; thought Atkinson was in the alley when Titus was shot; heard Othello say, 'd-m him, I would shoot the Queen if she interfered with my' coming past where Titus lay, he said, 'let him lay there and die.'
