MR. VANWART FOR MAYOR.

It is apparently settled, that Wesley VanWart, the well known barrister, will be a candidate for the mayoralty of Fredericton in the election which occurs in March next. The candidacy was not of Mr. VanWart's seeking, but in obedience to a very largely and influentially signed requisition which has been circulated during the week. We do not know who will be in the field in opposition to Mr. VanWart. Mr. Jordan is said to be canvassing for the position, but as between the two gentlemen THE HERALD has no difficulty in making a choice. It is just possible that Mr. Jordan, seeing the hopelessness of a contest against so popular and well equipped a candidate as Mr. VanWart, may retire, and allow the latter an election by acclamation. We understand that the requisition to Mr. VanWart bears the names of the largest taxpayers and most representative men in the city, who recognize in the proposed candidate a gentleman well fitted in every way to fill the civic chair. Mr. VanWart is a successful lawyer, an excellent business man; he has plenty of energy, decision of character, and knowledge of how public business should be conducted. Withal he is a genial gentleman, easily approached, and one who will give all the attention necessary to the proper discharge of duties pertaining to the mayoralty. As we have said, it is just possible that he will not be offered serious opposition but, if such a contingency should arise, THE HERALD is prepared to expend whatever influence it may be able to exert in support of Mr. VanWart's candidature. There are a few people who say that civic politics sometimes run in political grooves, but so far as THE HERALD is concerned, it only seeks the election of competent men to the mayoralty and council, no matter what their political opinions may be. Mr. VanWart is a Conservative, but the way he may cast his ballot and exert his influence in a Dominion election has nothing to do with his qualifications for the mayor's chair. We want a careful, prudent man at the head of the civic government, and this we say without any reflection on the men who have filled the office. We believe there is not a city in America with clearer civic record than Fredericton. The great majority of the men elected to the council go there with a desire to faithfully serve the public. There is no hope of personal gain in the transaction, but there is the certainty of much personal inconvenience, the sacrifice of considerable time, and the awakening of oftentimes senseless criticism. The election this year will have a privilege never before extended to them, and which was obtained by the present council. Every man entitled to vote will be able to cast his ballot for ten aldermen, a number representing the entire board. Hitherto an elector only voted for two candidates in his own ward, unless possessing property qualification in other wards. Every alderman elected this year then will represent the majority vote of the whole city, just as the mayor does, and the promoters of the new law believe that the change will prove satisfactory to the city. Another feature which ought to give greater interest to future civic contests, is that the mayoralty and aldermanic elections will be held on the same day, and there will only be two polling places in the entire city. THE HERALD would like to see a renewed active interest in civic affairs. Every ward in the city should present suitable candidates for the electors to choose from. There has been entirely too much indifference among the ratepayers and men have been elected to the council whose actions have brought the blush of shame to people who take pride in the honor and good name of the city. The council is no place for buffoons and blackguards, for men who have axes to grind or personal spite to satisfy. Let men only be elected who will bring a fair share of common sense, honest intentions and intelligence to the discharge of their duties, and we shall be spared the humiliating scenes which marked the council proceedings during the past year. If the citizens elect Mr. VanWart mayor, as we have no doubt they will, they should see to it that he is surrounded by aldermen who not only respect themselves and are prepared to honestly administer the civic business, but who are also representative of the intelligence and public spirit of this beautiful little city.

THE CARLETON ELECTION.

Our Opposition friends will now have an opportunity of testing their strength in Carleton county. The bye election in that constituency will be held on January 24th. Dr. Atkinson, who has doubtless had his card prepared for months, announces himself in the field, without waiting for a nomination from his friends. His address to the electors is a very abusive and silly production, showing the leading characteristics of his author. We are given to understand that even the Opposition in Carleton would much prefer the Doctor keeping out of the contest. He is generally disliked, and very little confidence is placed in his political "principles." However, there is but little fear that they will be troubled with him as a representative. The government candidate is not yet announced, but the gentleman who receives the nomination will carry the county.

THE LIBERALS OF ANTONISH.

The liberals of Antonish, N. S., the county represented by the late Sir John Thompson, have nominated Hon. Colin McLease, a member of Mr. Fielding's government, and hope to redeem that constituency.

UNLAWFULLY PAID.

There has been a great deal of lively discussion among the citizens over the recent payment by the city council, of the Hooper bill, an account made up for prosecutions under the Scott act. It appears that the information, which dates back to 1883, were laid by Miss Hooper, and that she employed J. W. McCready to appear for her when the cases came up before the Police Magistrate. Mr. McCready was not in court merely for his health, neither was he there in the interests of a great moral reform. He took the case with the expectation of receiving the cold cash, and when the investigations were concluded, he sent in his bill to Miss Hooper, who, instead of paying her lawyer, appealed to the city council for the amount due him, the bill being made up to ninety dollars. The council, considering that it had not employed Mr. McCready, and possessing a legal adviser of its own, who could have done the work, if necessary, declined paying the bill. Then Miss Hooper followed with a petition, asking for the payment, but this was shelved. Mr. McCready himself next appeared on the scene. If he could not secure his costs in any other way, he would invoke the assistance of the supreme court. Accordingly, he applied for a mandamus against the city, to compel the payment of the account, but by a unanimous decision, the judges declared that the city was not legally liable for the payment.

The matter rested here, until a few weeks ago, when Ald. Gilman resuscitated the Hooper petition from the dusty shelves, and had it referred to the assessment appeal committee for consideration. This committee, as readers of the Herald already know, by a majority of one, recommended the payment of the account, and the city council, by a vote of six to four, adopted the recommendation. A cheque was issued to Miss Hooper, and no doubt, Mr. McCready is now in possession of the amount. These are the main facts in the case, and are detailed now that the citizens may know just what the Hooper case means. The bill stands on that a majority of the council, consisting of the aldermen from Wellington, Kings and St. Ann's wards, voted ninety dollars of the public money, without any warrant in law, and of course, must take the responsibility of their act.

The generous donation of Mr. Medley and Mr. Wilnot to the funds of Victoria Hospital will very materially assist the management of that institution in paying off their indebtedness, but \$300 more are necessary to entirely wipe out what is owing. Here is a chance for our philanthropists. The hospital is a most deserving institution; it is economically and successfully managed, and its management should be placed above the incommensurate amount of want of funds. Persons desirous of contributing should send their donations to L. W. Johnston, the treasurer.

The Sun has been very anxious for the issue of the writ in Carleton county, and its desire is now gratified. Perhaps our friend might now exert himself in stirring the Dominion government up to bringing on the bye-elections in Quebec West and Verchères. The former seat has been vacant nearly a year. Then there is Antigonish vacated by the late Premier's death. Consistency is a thing to be admired in a public journal, and the Sun has now the opportunity of making a reputation for itself.

Hon. S. L. SHANNON, who died at Halifax, Monday, at the ripe age of seventy-nine years, was one of the best known and most highly respected citizens of the Nova Scotia capital. He was a member of the legislature from 1859 to 1887, and for a time was a member of the Nova Scotia government. Since 1881 he has been Judge of Probates. Mr. Shannon's wife, who with eight sons and daughters, survives him, is a sister of Hon. Jas. I. Fellows.

The Toronto Globe, the leading newspaper in Canada, has been burned out, losing its beautiful building and all its plant. The publication of our contemporary goes on however, temporary quarters being provided by its rival the Empire, and the two big newspapers are written up in the same office and printed from the same press.

A Tory newspaper in noting the fact that the Liberals of Saskatchewan have offered Hon. Mr. Laurier a nomination for parliament, suggests that the Opposition leader take his gun along with him. There is no need of that; the electors of the North West have the guns and they will be turned on the government when the proper time comes.

The report is revived that Hon. Geo. E. Foster will offer for election in York, but it is hardly credited. York has never yet had to call in the aid of an outsider to represent her, either in the federal or local parliaments, and the time for such a humiliation has surely not arrived now.

Hon. M. J. Power, who was speaker of the Nova Scotia House of Assembly during the two past terms, died yesterday at Halifax. He sat for Halifax in the assembly for twelve years, but was defeated in the general election of last June.

We are glad to observe that the Alumni Society of the University have taken up the question of college residency, and hope they will not relax their efforts until the students are comfortably domiciled on college hill.

AROUND THE WORLD.

The News of the World in Brief - The Cream of our Exchanges.

General Booth has reached Vancouver. L. R. Harding of Wakefield, has been elected warden of Carleton county.

The West Algona and Kingston by-elections will take place on January 28.

The bye election in Carleton will take place on the 24th inst, nomination on the 17th.

York Municipal Council and the adjourned sitting of the Circuit Court open next Tuesday.

Governor Morton of New York, can draw a cheque for \$10,000,000, and get it cashed, too.

Hon. W. Laurier and Sir Oliver Mowatt are to address the Liberals of Montreal Tuesday night.

The new steel highway bridge between St. Stephen and Calais is to be formally opened on the 19th inst.

The report that General Herbert had resigned is contradicted by both the General and the Minister of Militia.

At Dunnville, Ontario, Wednesday evening, James Gaulth and Miss Jennie Noble were drowned while skating.

The leading physicians of New York admit that an epidemic of deadly gripple is raging in that city, and deaths therefrom are reported.

The warship Blenheim, which brought the remains of the late Premier from England, sailed from Halifax Thursday morning for Portsmouth.

General Sir Henry Frederick Posenbury, private secretary to Queen Victoria, was stricken with paralysis at Osborne Cottage Monday, and is now in a critical condition.

Lizzie Brown, a Mott street, New York, unfortunately seized a lamp and threw it at Bridget Gorman, whose clothes became ignited. The latter was literally cremated.

Dr. Selwyn, chief of the geological survey of Canada, has been superannuated and succeeded by Dr. G. M. Dawson, son of Sir Wm. Dawson, late principal of McGill university.

The New York Journal of Commerce estimates the fire losses of the United States and Canada for the month of December at \$10,321,000, and the total for the year at \$128,246,400.

The Toronto mayoralty election Monday resulted in the return of Mayor Kennedy by 45 per cent. of the vote. Kennedy's majority over the same opponent last year was 4,416.

Duels are more serious in Germany than in France. On Monday at Berlin, Captains Burk and Rittler, of the German navy, fought a duel with pistols, and the latter was killed at the first shot.

While Melvin Hayward was working in the woods near Hartland, Carleton Co., Thursday, hauling cedar, one of the logs bounded against a stump and sprung, striking him on the side, killing him almost instantly.

L. P. Purpee, a New Brunswicker in the Marine department at Ottawa, has been appointed private secretary to Hon. A. R. Dickey, the new Secretary of State, who will get his election in Cumberland on Tuesday, by acclamation.

The People's Bank, Fredericton, has declared a dividend of four per cent. for the half year. The Bank of Nova Scotia has declared a half-yearly dividend of four per cent., and the Merchant's Bank of Halifax a half-yearly dividend of three and a half per cent.

George W. Davis, aged 26 years, suicided at Cleveland Monday night while his prospective bride, Miss Annie Noonan, was waiting for him at her home. They were to have been married that night, and Davis' mother, it is said, upbraided her son and opposed the marriage on social grounds.

Eugene V. Debs, and the other officers and directors of the American Railway Union, went to the Cook county goal Tuesday to begin serving the six months' sentence recently imposed on them for contempt of court. Their appeal to the Supreme Court is pending. In the meantime they will stay in goal.

Esten Williams, for twelve years a clerk in the Ontario educational department, has been suspended pending the investigation of a serious charge. It is that of purloining private letters and documents for the purpose of making copies or photographs of them to be used against the government in the elections.

A London cable states that there is little doubt but that the privy council will sustain the appeal of the minority of Manitoba from the judgment of the Canadian Supreme Court, when the latter decided that the minority had not the right of appeal to the governor general in council for remedial legislation.

A serious and probably fatal accident occurred the other day to the four year old son of Oebrauna Tracy, in the second tier, Jacksonville. He was kicked on the head by a horse. His skull was fractured above the left ear. The fracture extended to the base of the skull the extent of the fracture being about two and a half inches. Drs. Colter and Curtis operated, removing the upper piece of bone, and resetting the balance, but the patient's condition is serious.

An Ottawa despatch says: There is reason to believe that the question of the union of Newfoundland with Canada is receiving attention in high circles, and that as a result we shall shortly be face to face with a proposal to take in the island colony." The present crisis, the despatch says, renders the prospect of Confederation possible. The appointment of Sir Ambrose Shea, it is added, is another important factor, while the Ottawa government is willing.

The Admiralty have selected the new first-class protected cruiser Crescent for service as flagship on the North American and West Indies Station, in succession to the cruiser Blake, which was commissioned at Chatham on February 2, 1892, and will shortly complete her first term of foreign service. The Crescent is a twin screw vessel of 7700 tons and is built at Portsmouth in 1892; 12,000 horse power against the Blake's 2000. She steams 19.5 knots and carries 850 tons, and at 10 knots speed can travel 10,000 miles without coaling.

The east bound C. P. R. train ran off the switch about seven o'clock Saturday morning at Lowellville, Maine, where it was supposed to cross with the west bound passenger train. It appears that the switch to the eastward of the station had been opened for the west bound train to run in on the siding and allow the east bound train to pass along on the main track. The latter arrived first and proceeded directly to the end of the switch, intending to back up on the siding, but the switch being open, it ran off.

Fortunately, there was no loss of life or serious accident. Several cars were badly wrecked.
