ACTIVE WAR IN LIBERAL RANKS

Date of the Ward Meetings Changed.

On Account of the Pugsley Banquet—Emmerson Faction Confident—O'Brien and Tucker.

War began today. The two chief factions of the great Liberal party in this constituency which have been glaring at each other for the past couple of weeks have clinched this morning. And the fur is flying and is going to fly even more copiously from now on.

The immediate cause of the quarrel was the date for the ward meeting. It so happens that those who have leanings toward Mr. Emmerson's side have practical control of the machine just now, and they, without any hidden motives, of course, fixed the date of the ward meetings for Thursday night.

The date was announced in prominent advertisements in the morning's papers.

Now Thursday night is the night of the Pugsley Banquet at which several of those who think they have considerable influence in local politics plan to be present. But even they could not be in two places so far apart as Caladonia Springs and Montreal at the same time and some of them are mean enough to declare that those who fixed the date of the meeting, did so with this end in view.

Anyway there was an awful row and many jarred and heated conversations this morning as a result of which the order came to the Star office about one o'clock this afternoon to change the advertisement in the morning papers so as to make it read "Wednesday, Oct. 8th," instead of "Thursday, Oct. 8th."

So the Russell-Pugsley combination have won the first skirmish and the supporters of the Boom will be able to attend the ward meetings before the train leaves for the Banquet.

That's about all in the local political market today, except that the Emmerson people are confident of nominating their candidates in the coming convention. It is generally said that Richard O'Brien and Col. Tucker will comprise their ticket.

BUZY POLICE COURT.

Seven Drunks and One Question-Character Fined—Liquor Sold Saturday Night.

The police court docket this morning was unusually large.

Harry McDonald, aged twenty-two, given in charge by Clerk Dunham, of the market for drunkenness and disorderly conduct in a public place on Saturday night, was fined eight dollars.

Patrick Whalen, aged thirty-seven, was arrested by a young man on Saturday night and carried to the central jail. On his person was found a dangerous looking razor. This morning he was fined \$5 or two months in jail and in addition was debited with twenty-five cents for cartage.

Carl O. Nelsen, aged twenty-four, hailing from Denmark, was arrested by Officers Campbell and Scott on Saturday for discharging a revolver on the South wharf. When arrested he had two loaded cartridges in his pocket. He deposited \$15, which he forfeited.

Walter Chamberlain, aged twenty-six, forfeited \$5 for drunkenness. Others who forfeited deposits were Michael Sullivan, Wm. Elliott, Edward Ready, Jas. Scott and Jeremiah Denison.

Reed Tharber, a young man who works as steward on the steamer St. Croix, was in court to answer the charge of loitering and loitering in the vicinity of the Bank of New Brunswick and failing to give a satisfactory account of himself. Tharber explained that he had been there just about five minutes when the officer approached him. He was fined \$5.

A very deplorable case this morning was that of Isaac James Logan, a young man, nineteen years of age, who was arrested for drunkenness. He was allowed to go on the supposition of his mother, Young Logan, when questioned by the magistrate, and that it was since eleven o'clock when he left the place. The magistrate remarked that this was a very serious matter and should be investigated.

Magistrate Ritchie in court this morning alluded to an incident which came to his attention yesterday. A young lady returning from Trinity church last evening was approached and insulted by an unknown man. He begged the police to have a sharp look out for such persons to whom he would mete out severe punishment.

JAPS LOST 20,000 MEN IN FOUR DAYS FIGHTING.

Awful Carnage in Prolonged Attack on Port Arthur—Russian Steamer Sunk—Japs May Attack Vladivostok.

CHE FOO, Oct. 3, 2 p. m.—An official report from General Stoessel, dated Sept. 23rd, reached Che Foo to-day, confirming a previous report of the capture of the Japanese attack on Port Arthur. It began Sept. 19 and ended Sept. 22. The fighting was of an extremely severe character. The Japanese having retired General Stoessel issued the following proclamation:

"Glory! Thanks to God! Glory to our heroic garrison! Glory to Ilman, Sychaft and Pogorsky—Heroes all! Thanks to our valiant volunteers who routed the enemy from the trenches, destroying them. God has permitted us to repulse the enemy. Praise to God!"

The volunteers referred to by General Stoessel were made up of regulars called upon to take a high hill which had been captured by the Japanese.

From semi-official sources it is learned that the attack began on the 19th along the whole line and lasted four days various positions changing hands many times.

The high hill mentioned was a very important position to the Russians. The Japanese attacked repeatedly day and night, finally occupying the position on the night of Sept. 22, after suffering very severe losses. The attempt to re-take this hill being extremely hazardous, General Stoessel refused the order, but called for volunteers. Everybody called upon responded, whereupon a requisite number of men were selected. Lieut. Pogorsky and Captain Sychaft leading them. Soldiers and officers alike carried grenades (explosive shells weighing from two to six pounds, which are thrown by hand) and with these they attacked the Japanese temporary fortifications and drove the latter from all their positions. Several mines were exploded during general battle, causing severe losses.

The Russians calculated that the total Japanese losses for the four days fighting reach 20,000 men.

SUSSEX SHOW THE REST YET

The Exhibition Which Opens Today Will Break All Records—Great Horse Racing.

(Special to the Star.) SUSSEX, N. B., Oct. 3.—Exhibition matters are progressing favorably. The weather bids fair to be fine, entries are coming in rapidly, and exhibits are being placed in position. The exhibition will be formally opened tonight. The stock exhibits will be large and of the best probably shown for years.

Great interest is being manifested in the races which bid fair to be the best ever held on the track. There are fifteen entries for the 220 class; nine or ten in the 235; six in the 240; five in the free-for-all, and seven in the green race. There are 43 horses entered, and 40 of them are expected to start.

Hotels and private lodgings are filling up rapidly and there is every indication of a splendid attendance. The exhibits of agricultural products, local manufactures, poultry, swine, sheep etc., will be large and varied. All indications toward this being the best exhibition ever held in Sussex.

THE SPOTTER HERE AGAIN.

Two More Employes of St. John Street Railway Have Been Discharged.

St. John Railway Co. employes, or rather ex-employes, show another Montreal spotter is at large in the city, and as a result two of the regular men, a conductor and a motorman, have been discharged. The discharge was made Saturday.

MARCONI STATION MOVED.

(Special to the Star.) MONTRÉAL, Que., Oct. 3.—John D. Oppé, vice president and general manager of the Marconi Co. in an interview today, says that Marconi will go to Glouce Bay in a fortnight. In view of the immense strategic importance of uninterrupted communication between Canada and Great Britain, the station will be moved some distance inland to a less exposed position. Improvements will be incorporated in the new station, which will be in operation in three months. All the expenses of moving are being borne by the company.

CITY WILL OWN MISPEC MILL.

Its Tender was the Only One Received.

City Bid \$115,000—Its Acceptance Will Probably Save \$200,000 in Damage Suits.

J. A. Likely and E. B. Ketchum, liquidators for the Mispec pulp mill property, when seen this morning refused to give out any information concerning the tenders. They said the matter has not yet been settled and would likely remain in this condition for a few days.

However, the Star learns that the city's offer was the only one received by the St. John Sulphite Company and would probably be accepted. The council's tender was \$115,000. This, in the mayor's opinion, means the saving to the city of over \$200,000 in possible law suits; besides by this transaction they gain a property worth at least \$300,000. The plant may be utilized in the future in a scheme for municipal lighting and in any case is a valuable asset.

Had the city not bought this property, the extension of its water system to Loch Lomond would have caused damage suits from this company, not only equal in value to the money represented in this property, but also for the prospective profits for years to come.

The mayor was the originator of this scheme to head off law suits, and was strongly supported by the aldermen and F. A. Barbour.

ARLINGTON CO. WOUND UP

Well Known Mining and Milling Company's Came to an End This Morning

In the supreme court chambers this morning, Judge McLeod, on the application of E. R. Chapman, made an order to wind up the business of the Arlington Mining and Milling Company, whose property is situated in Halifax county, Nova Scotia. Charles T. Bailey, secretary of the company, was appointed provisional liquidator.

This company was incorporated by the late John men, who now are by far the most heavily interested owners. The company since its incorporation has carried on extensive development work, with no financial return. Lack of capital for the continuing of the business of the company compels the winding up of its affairs. The capitalized stock of the company was \$200,000. Its liabilities are about \$150,000.

PEACE CONFERENCE BEGINS IN BOSTON.

NEW YORK, Oct. 3.—Angry because of his attempts to force his undusted affections upon her and determined to repulse him at any cost she declares, Mrs. Rosa Barabadi, 23 years old to-day, shot and killed Michael Rago, in an East Side tenement house. The first shot was fired in Mrs. Barabadi's apartment into which she says Rago had forced entrance and the second in the doorway of the house in full view of hundreds of persons. Both bullets struck Rago in the head. Mrs. Barabadi made no attempt to resist arrest and was taken to a police station carrying her two year old baby, which she had held in her arms when she fired the fatal shots.
