TRAGIC DEATH OF M. F. T. HARRISON

Deputy Collector of Inland Revenue Killed by Accidental Discharge of His Shot Gun

William F. T. Harrison, deputy collector of inland revenue department, who resided with his mother, the widow of the late W. F. Harrison, was killed this morning by what is generally conceded to be the accidental discharge of a shot gun.

The accident happened about eight o'clock and as far as can be ascertained the circumstances are as follows: The family were breaking up house-keeping, Mrs. Harrison intending going to Toronto to reside with her daughter, Mrs. Hart. The deceased had remarked the night before that he would pack his guns, ammunition, etc. early in the morning and for this had a large packing case.

The late Mr. Harrison was born on the 23rd of July, 1875, and was appointed to the inland revenue department on July 13, 1901. He leaves besides his mother one sister and two brothers, Walter, with the late Rev. Edward Harrison, who is making a name for himself on the American continent, and an elder brother, Capt. Chas. Harrison, who died while with a Canadian contingent in South Africa.

HAD TWO HUSBANDS HALF A MILE APART

Matrimonial Adventures of a 20 Year Old Girl.

Told Husband Number One That She Was Going to a Wedding—She Was the Bride.

CHICAGO, Ill., Sept. 19.—A despatch to the Record-Herald from Butte, Mont., says:— Two weeks ago the 20-year-old wife of George Melville, miner, told her husband she was going out to attend the wedding of a friend. Yesterday it was discovered that she was the bride and had married Harry Northey, a young man living less than half a mile from her home.

Mrs. Melville had told Northey that Melville was her uncle, and she did not want him to know of her marriage for a while, as she feared he would cable the news to her mother, who she said, is an invalid in London.

She went back and lived with Melville for a week, then returned to her younger husband and remained with him until yesterday, when Melville succeeded in finding her. She denied him, and declared he was her uncle and not her husband. Northey believed her, notwithstanding the records of the court at Great Falls which show that she married Melville in August, 1901.

The girl four years ago was married to a man named Walbridge, who abused her, and was killed by her father, for which crime the father, Mr. Hunter, is serving a sentence in the state penitentiary. The young woman was arrested on a charge of bigamy.

M. WITTE IN PARIS ON HIS WAY HOME.

PARIS, Sept. 19.—M. Witte, accompanied by his wife and daughter and several members of the Russian mission arrived here today after a tedious night ride from Cherbourg. Following the express wish of the Russian statesman, there was no formal reception and only a few intimate friends gathered at the northern railroad station.

A crowd of travellers respectfully saluted M. Witte who bowed his acknowledgment. He appeared to be much fatigued by the voyage, entered an automobile and was conducted to the Hotel Bristol. M. Witte will make a brief stay in Paris conferring with ambassador Nelidoff and then will depart for Berlin arriving in St. Petersburg on Saturday.

REGORIAN CHANT DEPLETES CHOIRS.

NEW YORK, Sept. 18.—Efforts are being made in the Catholic metropolitan diocese to introduce the Gregorian chant in the churches as speedily as possible to sing the soprano parts may be trained. This has caused many of the girls and the women singers to resign their positions in the choirs and to seek engagements in non-Catholic churches.

Many of the churches in the archdiocese have already complied with the papal instructions on the subject. The new arrangement has been adopted at the Cathedral, and yesterday, when the Eighth regiment attended services there, the choir was made up entirely of men. The Gregorian chant is entirely used by the Paulist Fathers, and recently it has been introduced at the churches of St. Francis and St. Ignatius.

Women singers are retained in some of the churches, but their presence is considered only temporary, and as fast as they can make arrangements they are accepting contracts from other religious denominations.

TUGS HAVE GONE TO BRING DREDGE

The tugs Flushing and Lord Kitchener left this afternoon at 2 o'clock for Boston to tow the dredge Beaver here. The Beaver is the dredge secured by C. S. Mayes for the work preparatory to the building of the new wharf at Sand Point. With fair weather the tugs should be back with the dredge and scows in a week's time.

THEOSOPHISTS IN SESSION.

CHICAGO, Sept. 15.—The Theosophical Society in national convention here yesterday elected Alexander Fullerton general secretary and treasurer. F. N. Notke, of New York, and G. H. Harwood, of Toronto, Ont., were chosen members of the executive committee. There were 4,000 delegates in attendance at the convention in Mexico, Canada and the United States.

RUSSIA'S NEW TARIFF BOOMS YANKEE TRADE.

ST. PETERSBURG, Sept. 19.—The removal of retaliatory duties of American imports has already proved a great stimulus to American trade here. The agents of American houses have received directions for the shipment of engines, pumps and other machinery as soon as the order rescinding the duties takes effect. This prompt action of the agents is necessary in order to land goods at Cronstadt before closure of navigations so as to avoid the heavy costs of railroad transportation from the ice free ports in the southern seas, and also in order to take advantage of the favorable rates under existing treaties because before navigation is reopened the new and higher scale of duties based on the treaty recently made with Germany will be in effect.

JAPAN READY FOR GREAT DEVELOPMENT.

TOKIO, Sept. 19.—(Non.)—Despite the fact that the ebullition of popular dissatisfaction over the peace arrangements continues unabated there are indications that the business contingent is slowly sobering down. The capital intended for new enterprises following the successful conclusion of the treaty of Portsmouth is gradually coming into the banks as deposits in amounts likely to lower the rate of interest. The profound disappointment which has prevailed has at last proved a benefit to the extent of saving the people from any feverish intoxication resulting in bubble enterprises like those which accompanied the close of the war with China. The money class has resumed the attitude of caution and frugality which guided its transactions during the war, the financial outlook is not gloomy and capitalists are patiently awaiting solid investments.

DUTCH GOVERNMENT'S EXTENSIVE REFORMS.

THE HAGUE, Sept. 19.—The states general were reopened today. Queen Wilhelmina's speech after expressing her pleasure at the ending of the far eastern war, dealt with international matters. Her majesty said the financial condition of the country necessitates a better administration, as the revenues, though increasing, were not keeping pace with the expenditures. An extension of the sources of revenue was necessary for education and social reforms. Regarding the military of the country the speech proposed the universal preliminary training of the youth of the nation in order to make the whole people available for defense. The speech also proposed obligatory insurance against illness and death.

DISABLED STEAMER AT HALIFAX (Special to the Star.)

HALIFAX, N. S., Sept. 19.—The German-Lloyd steamer Bremen, from New York for Bremen, was towed in here today by the steamer Lugton. The Bremen lost both propellers and was taken in tow four days ago.

CUSTOMER'S SLAYER IS DEAD.

ABERDEEN, S. D., Sept. 18.—Rain-in-the-Face who was one of the leading chiefs in the Custer massacre, and is said to have personally killed General Custer, is dead at the Standing Rock Reserve. He was 62 years old.

SOOMING THE CARNIVAL.

The executive committee in charge of the autumn carnival (see page two) conferred this morning with the representatives of the railways, with reference to cheap fares for the week beginning October 18th. The C. P. R. has promised favorable consideration of the proposition to give one first class fare to visitors to the city during the whole week, and John M. Lyons, the general passenger agent of the I. C. R., is coming to this city tomorrow to make arrangements with reference to his road.

FOOTIS STORIES MOVED AGAIN.

As the county authorities and others have taken no action in the case of Fotis Storis, the Greek bootblack, Sheriff Ritchie, from a humane standpoint, considered to admit the man into the county jail. He was taken from the police station cell about eleven o'clock this morning, and will be kept in jail until some other arrangements are made for his care.
