It is hardly necessary to say to those who know the people of *Hillsburgh* and *Bridgeport*, that our friends did all in their power to accommodate and render comfortable, the large multitude that attended during the meetings. May rich spiritual blessings reward their hospitality and kindness!

An Enquiry and Answer.

DEAR SIR,—I think it is very desirable that the business of Christian Churches should be properly transacted, and that their records should present in a clear and concise form a fair history of their proceedings. I am afraid this is not always the case, and, as a question has arisen in my own mind on one point in reference to the mode of doing this, I have thought it might not be improper to submit the same to yourself or to some other brother, whose acquaintance with such matters would enable him to give an opinion entitled to respect.

My question is this: Is it right or necessary that every resolution offered at a church meeting be recorded, whether it be carried or lost? Or rather, I might say, if a resolution is moved and seconded and after discussion is lost, should such resolution appear on the minutes of said meeting?

I think there is a difference in the practice of societies in this particular; some do record such resolutions whilst others do not. The question may appear trifling, but it is one on which the perspicuity and brevity of a Church's history largely depends, and one in which, I presume, other Churches besides that of which I am a member may be interested, and I should be glad, therefore, to have an answer to it through your columns:

In replying to our friend "Scribe" we would respectfully suggest that while the Church does in some respect resemble an ordinary society, yet, in others it is of a very different character. One of these differences, we hold, is that of being a permanent body—not to be dissolved at the option of its members, but to be perpetuated until Christ its head shall come; another is that its laws or perhaps more correctly, the principles under which it must act are already enacted and must be obeyed—no new enactments, at variance with those of Christ himself, are admissible in his church; another principle is, that, to accomplish the purposes of a church, unanimity must prevail. Some difference of opinion may exist but on the vital points of faith and practice there must be but one spirit prevailing. All should be "perfectly joined together in the same mind and in the same judgment" 1 Cor. i. 10. Each member must be a believer in the Lord Jesus and willing to submit to his authority and guidance. With these preliminary remarks we may suggest that on the question itself, nothing appears in the Word of God except such as may refer to a church being of one mind and minding the same thing. These would appear to favor the rule adopted by our Association:

"Motions made and lost shall not be recorded on the minutes except so ordered at the time."

A similar decision is given in Hiscox's Baptist Church Directory, page 105.

"A motion lost should not be recorded on the minutes except so ordered by the meeting at the time."

It may be the practice in some representative and legislative bodies for motions to be record-

ed, whether lost or agreed to. In this particular, however, we do not think they afford any criteria for the action of christian churches. In the world's legislatures two distinct parties are ordinarily recognized. And whilst all questions are decided by a majority, yet the minority usually have a leader and as distinct an organization as the majority, and hope by fair argument or by stratagem from time to time to strengthen themselves so as to be able to supercede and step into the places occupied by their opponents. The church we think should exhibit no such tactics, and should countenance nothing which savors of division. For these reasons we conclude that it is advisable to act in accordance with the above rule of the Association and other authorities, than after the manner of political life.

NEWS SUMMARY.

The steamship *Java* arrived on Monday afternoon, with but little news in addition to that already received by Atlantic telegraph.

The position and effects of Trades Unions are being canvassed somewhat severely. One cause of this is a suit entered by a number of Master tailors against the president, secretary and other officials of the Operative Tailors' Association, for "conspiring to impoverish certain master tailors by inducing men not to work for them." Another cause is that a discovery has been recently made of a murder committed some years ago, having been effected by a member of a Trades Union upon a man named Linley a Non-Unionist, because he brought too many boys into the trade. Another man is charged with having violently assaulted a Non-Unionist.

The Birmingham Catholic riots appear to have been occasioned by a man named Murphy who the Daily News describes as having the tricks of a madman, among the other outrageous things, saying that "Every Popish priest is a murderer, a cannibal, a liar, and a pickpocket." He was the agent of a body calling itself, "the Protestant Electoral Union," an attempt doubtless to use the Protestant name for a party political purpose.

It appears that by the riots one or two streets were nearly laid in ruins.

The Princess of Wales is gradually recovering from the attack in the knee, from which she has been so long suffering.

The *Owl* says that on the occasion of the Sultan's visit to England it is arranged that her Majesty is to receive the Imperial visitor on board her yacht, and conduct him in person to witness the manoeuvres of the great naval review at Spithead. Lord Raglan has been appointed to attend on the Sultan during his Majesty's visit to this country. The Sultan will leave Constantinople on the 22nd inst.

Although the French army is actually withdrawn from Rome, France is now taking somewhat unusual steps to provide for the maintenance of a force of Pontifical Zouaves around the person of the Pope. This is now regarded as a religious work of a high order of merit, and quite a spirit of emulation is indulged in by the French Roman Catholics, who are striving to send as many men as possible to Rome, each furnished with a purse of 500 francs for his maintenance in the Papal army for one year.
