A boy named Mahoney fell over Tobin's Wharf on Saturday, and was insensible when taken out of the water. By the prompt use of restoratives he recovered.

ACCIDENT.—A serious accident occurred on Saturday. Several men were engaged in hoisting a boat into a loft. It had reached the desired height, and was being hauled into the loft, when the fastening slipped. The boat fell, striking a man named Patrick Neely, breaking his thigh and causing other severe injuries.

On Friday last, a horse employed at Richmond Depot, was run over by a locomotive and killed.

A POLITICAL INDICATOR.—The *Acadian Recorder* dubs Mr. Howe the "Fairfield Weathercock."

THE POORS' ASYLUM.—The number of inmates in this institution is said to be 428, which is being added to every day. The new building is much needed.

F. W. PASSOW, Esq., has been appointed Deputy Inspector of the U. S. Post-office Department. His long and faithful services in connection with the Postal service renders this a judicious appointment.

FIRE DEPARTMENT.—The basement of the Engine house on the Parade is to be fitted up as a drying-house for the hose. This has long been required.

ST. MARY'S CATHEDRAL is to have a new front. The design for the elevation is on exhibition at Wetmore's, and is certainly very handsome. The top of the spire is to be about 175 feet from the basement.

FOUND DROWN D.—The body of a man named Herman Kenny was picked up in Pitts Dock, Upper Water Street, on Friday last. The deceased was a seafaring man, a native of Barrington, and only arrived here from Penascola, a few days ago. It is supposed he fell over from the *Schr. Speed*, lying at the above wharf, on Sunday night last. An inquest was held to day, and a verdict of "found drowned" returned.

A young man Charles Pineo, about 18 years of age, son of Mr. George C. Pineo, has been missing since Tuesday evening. He was last seen in a house in Barrington street, and had evidently been drinking. It is supposed that he has shipped on board some vessel for the West Indies.

LOCAL TELEGRAPH.—The Imperial Government intend constructing a serial telegraph line from the Citadel to Point Pleasant, and thence across to York Redoubt.

Sir William Logan left this city on Friday last for Ottawa. He has been making a survey of the Pictou Coal fields.

RELEASE OF ROCKHEAD PRISONERS.—The Lieut. Governor has informed the City Council that in future no prisoners are to be discharged from Rockhead before their term of sentence expires, without previous application to him. The City officials have been in the habit of discharging them on their own responsibility, but the Lieut. Governor is of opinion that the power belongs solely to the representative of the Queen. It is not yet decided whether by the Governor-General or the Lieutenant-Governor.

THE EARLY CLOSING ASSOCIATION is again in operation. The first lecture of the season under its auspices, will be delivered by the Hon. Joseph Howe, on Monday evening, November 30. His Honor the Chief Justice will preside, and a band will be in attendance. The second meeting will probably be held in the evening of Monday, Dec. 28, when Rev. Geo. W. Hill, will lecture, to be followed with readings by F. W. Passow, Esq., and music by a first class band.

THE MANCHESTER EMBEZZLERS. Carr and Garwood were fully identified by the Detective Sergt. Torrent out for them. He took them home in the R. M. S. *Etna* on Friday last.

THIEVING.—A woman was arrested at the Depot on Wednesday last, having on her person some furs which were stolen from the shop of Mrs. Bourdillault about a week before.

ACCIDENTAL DEATH.—Mrs. Saint who was injured by being knocked into the hold of a vessel at O'Neill's wharf, on Saturday the 10th, died on Thursday last.

THE FINE BRIDGE near Mount Uniacke has been in an unsafe condition of late, and has occasioned much inconvenience to travelling, as the locomotives have not been permitted to go over that part of the line.

RIVER PHILIP.—The *Amherst Gazette* says the house of Mr. Thomas Fillmore, River Philip, was destroyed by fire, with all its contents, on Tuesday night last.

A man named John Maikle, living at Westchester, had his leg broken on Thursday last while on his way to Turo with a loaded team.

DARTMOUTH.—Whilst our City Corporation are moving to enlighten the suburban darkness by oil lamps, it is a little surprising that the enterprising people of Dartmouth are not adopting measures of a similar nature. It would be a great benefit to the inhabitants and might be done at a very trifling expense.

CAPE BRETON.—The Railway from the Intercolonial Mining Company's Mines, is to be built in the spring. It is said the necessary arrangements are completed.

The Bridge across the Avon is progressing. One of the large girders, 18 feet high by 150 feet span is nearly finished.

T. H. RAND, Esq., Superintendent of Education, has returned from a visit to the western counties in relation to educational matters. We learn from the *Herald* that he gave a lecture in Yarmouth in which he spoke encouragingly of the improvement of the schools and the progress of education throughout the Province generally. He complimented Yarmouth for the interest, enterprise and liberality which she had displayed in the cause of education, and the efficiency of her educational institutions. He recommended that the three Town School Districts should be united in one, and the High Schools be made free to all the children of the County.

THE SHORE FISHERIES.—We regret to learn that the mackerel fisheries along the shore have been almost a failure. It is feared that much distress will be the result in many places during the approaching winter.

WINDSOR.—A man named Robert Brown, had three of his fingers crushed off, while loading the brig *Henry Gilbert* with iron at the Railway Wharf, Windsor, on Saturday last.

LOSS OF THE SCHOONER J. W. DEERING.—The *J. W. Deering* left Bear River on Thursday the 15th day of October, bound to Boston, loaded with wood, and on the night of the 17th ult., in that storm, the vessel sprung a leak, and capsized near Cape Ann, U. S., with all on board. Sad to relate, eight out of the ten souls on board were lost. Their names are as follows: Charles Sulis, Capt., Lost. Charles Sulis, Mate, Saved. Rufus Goodwin, Seaman, Saved. James Sulis, son of John Sulis, Lost. Walker Vroom, Lost. Henry Vroom, (boy) Cook, Lost.

Passengers Lost.—Mrs. Caleb Sulis, of Smith's Cove, Mrs. Douglas Craig and son, of Smith's Cove, and a young man from Moose River, by the name of Belmont. The Mate, Charles Sulis, and Rufus Goodwin got into the main rigging, and there remained all night until the next day, when they were taken off by the schooner *John G. Hall*, of Clementsport, and taken into Boston. The boy Vroom was washed fast in the main rigging by the Mate, and there died, and was taken to Cape Ann and buried.

Since writing the foregoing, news has just been received that the body of Mrs. Caleb Sulis has been found and will be brought home.—*Com. by William Aymer, Esq.*

NORTH SYDNEY C. B.—Mr. L. Roberson Secretary to the Board of School Trustees writes to one of our morning papers a good account of School matters in that Section. He says of the half yearly examination:

The thorough and complete control of the teacher over the school is a fine feature in the normal system of training; and Miss Norwood seems to understand it well. Most of the exercises gone through during the examination, were creditable to both the teacher and pupils, evidently showing a marked progress for the last six months. Prizes were awarded by the teacher and by the R. V. Mr. Porter, to several of the scholars for regularity of attendance and general good conduct. The children and parents present were addressed by the Rev. Mr. Porter and John A. Moore, Esq., both of whom congratulated the people of this Section on the completion of such a fine, large and commodious building, one of the finest, if not the very best school house out of Sydney, in the county, creditable alike to the people of this Section and to the contractor, the last named gentleman, who spared no pains in the erection and finishing of the structure to the full satisfaction of all concerned.

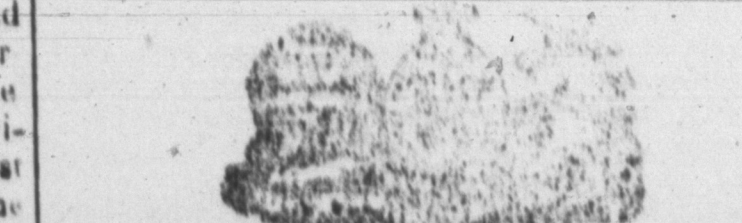
ON the recommendation of the Honorable the Minister of Customs, and under and in virtue of the authority given by the 10th section of the Act passed during the late Session of the Parliament of Canada, 31st Vic. Cap. 44, intitled:—"An Act to amend the Act of the present Session, intitled: "An Act imposing duties of Customs with the tariff of duties payable under it." His Excellency in Council has been pleased to approve of the following additional Regulations respecting Drawbacks claimed on the exportation of goods under the said 10th section of the Act above referred to, viz:—

REGULATIONS.

1st. Goods having been entered for duty and having passed into the hands of the importer, in cases where the said goods are found not to be the goods ordered, notice of such fact may be given to the Collector of Customs at the Port of Entry, within one month of the date of such entry, accompanied by a request for leave to return the said goods to the place and party where and from whom the same were purchased, and that the duties paid thereon be refunded; whereupon the collector having verified the statement of the importer, and having ascertained that the package to be exported is a whole package, and that its contents are identically the same as originally entered for duty, shall report the same to the Department, and the Minister of Customs shall thereupon issue an order to the Collector to refund the duties upon due proof of exportation; Provided that if such goods are not actually exported within one month from the date of such order it shall be void and of no effect.

2nd. Whereas cases frequently arise for which no general order or regulation is provided, in which goods upon which duty has been paid require to be exported, and injury or hardship may be endured by importers, to the disadvantage of the general commercial interests of the Dominion, unless some means of redress be provided. It is therefore ordered that in all such special cases, it shall be lawful for the Minister of Customs to consider the grounds and examine the merits of each application, and make such order thereupon subject to the approval of the Treasury Board; as may, in his judgment, be necessary for the relief of the parties, and consistent with the interest and security of the revenue.

Whereas it is provided by Cap. 5, of the Act 31st Vic., Sec. 10 sub sec. 5, that "the Governor in Council may make such regulations as may be considered advisable for the appointment of Sufferance Wharves and Warehouses at which goods arriving by vessels in transit to other Ports or confined to certain days of departure, may be landed and afterwards stored before entry;" And whereas it is expedient that the accommodation so contemplated should be afforded in all cases where the same may be found necessary,—His Excellency in Council, on the recommendation of the Honorable the Minister of Customs, and under the authority of the said recited Act has been pleased to order and it is hereby ordered, that on application to the Minister of Customs, by the owner or master of any Packet Steamer, or other vessel being a regular trader, specifying the name and tonnage of the said steamer or other vessel, the general time of her arrival and departure, and the ports between which she is accustomed to sail, also designating the wharf at which she is accustomed to land and the building in which it is proposed to store her cargo, it shall be lawful for the said Minister of Customs to declare the said wharf and building to be a sufferance wharf and warehouse for the purposes of the Act, and to authorize the Collector of the port to grant a warrant of license, for a specified time, to the master of such steamer or other vessel to land his cargo and store the same at the wharf and in the building so declared to be a sufferance wharf and warehouse, without previous entry, the said Master having previously executed a bond to the Crown in such penal sum as the said Minister of Customs may consider equitable, but not less than one thousand dollars, providing that the said Master will not fail to leave in the hands of the Landing Master or other Officer of Customs appointed for the purpose, a report of the Contents of his vessel for each voyage, and he will in all other respects conform to the requirements of the law in such case, and will use his utmost diligence to prevent any infraction thereof by any person or persons arriving at such port in his vessel.
