

to provide like accommodation for themselves and their children. The choir notwithstanding the disadvantages of being in a new place rendered several anthems in excellent taste before and at the close of the services. The singing during the day was largely participated in by the congregation; the organ and choir assisting to combine all the voices and make them as of one heart and one voice glorifying God.

The London Baptist Missionary Society, have made a very profitable exchange of their former Mission House and premises in Moorgate Street, for a new building which they have erected in Castle Street. They have saved by the transaction, we believe, nearly two thousand pounds. The *Freeman* says of the new House which was opened last month:—

"The site of the New Mission House is neither commanding nor attractive. Castle Street does not compare favourably with Moorgate Street. It is however, central and convenient, being easy of access, and within five minutes' walk of several leading thoroughfares. The building is all that could be desired. Never before has the denomination possessed so commodious a home. All the societies can be accommodated under its roof, and the large hall contains ample accommodation for some three hundred people. Were the house 'set upon a hill,' its architectural excellencies would be acknowledged by all. As it is, the architects deserve high praise for the manner in which they have made the useful ornamental. Messrs. Searle & Son have succeeded in the difficult task of building a house which satisfies all parties. Artistic skill, thoroughness in working details, and an evident regard to every day and even occasional requirements, combine to make the New Mission House everything Baptists can wish."
