

Those of our readers who were acquainted with Rev. Dr. Fyfe and his labors, will sympathize with the writer of the following, in regret at his departure, and with our Canadian brethren in the loss of such a valuable man and minister:

Death of Dr. Fyfe.

My Dear Sir,—

I deeply regret that I have to inform you of the death of Rev. Dr. Fyfe. His death will be a great loss to our Denomination.

I became acquainted with our deceased brother in 1844, where I found him in temporary charge of the Baptist College at Montreal, the presidency of which I undertook on my arrival from England. I have watched his progress ever since, and have rejoiced in observing the influence which he obtained among the Baptists of Ontario, and the skill which he manifested in moulding their religious institutions, especially in the educational department. Dr. Fyfe was largely gifted with the spirit of organization and government, and used his gifts "as ever in his Great Taskmaster's eye."

I apprehend that his removal was sudden and unexpected. He did not think that his task was so near its completion. Having succeeded in establishing the Institute on a firm basis, his next effort was to be the creation of an Endowment for its support, to which he looked forward with trusting expectation of success.

Writing to me on the 23rd, ult., he said, "I should like, if God will, to be spared till the school can, at least, be partially endowed. I think it has now such a strong hold upon the Baptists that they will not let it die." No! They will not!

It was not to be, however, in his lifetime. God has taken him, and God will find a successor. There are able men in Ontario to choose from, and our brethren, seeking to know the mind of the Lord, and unitedly supplicating his guidance, will doubtless discern the indications of his will.

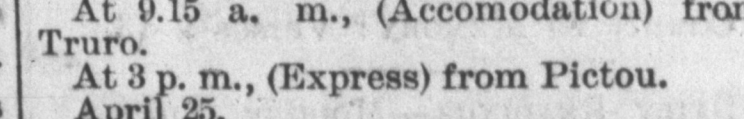

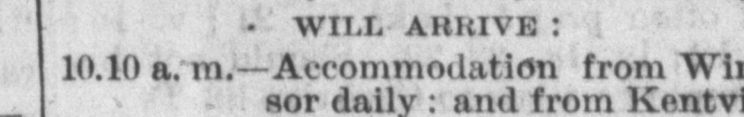
