PROVINCIAL APPOINTMENTS.—30 April, 1879.—Lunenburg Co., To be Trustees of the Common at Chester—Daniel Evans, William Smith, and James Smith, Esqs.

Halifax Co.—To be Commissioners of Schools for the Eastern District of the County—Malcolm McFarlane of Sheet Harbor, and John F. McKenzie, in place of John Balcom and Rev. Alfred Dickie, removed from the District; William C. Henley, Spry Bay; Andrew Gaston, Tangier; John C. Ross, Shoal Bay; James H. Whiteman, Salmon River; William McLearn, Quoddy; and Rev. James Scott.

Antigonish Co.—To be a Commissioner of Schools—Rev. Francis Broussard, Tracadie.

Pictou Co.—To be a Commissioner for taking Affidavits &c., James Roy, Westville.

The Grand Jury of Halifax County the other day reported to the Supreme Court that there were four indictments against the City of Halifax for having the streets obstructed with horse-car rails. The Judge ordered the city to be notified that if the obstruction were not removed the corporation would be liable for any damage occurring from neglect of so doing.

On Friday last about fifty tons of sand ballast from the barque Ella Vose stored on the end of Black Brothers & Co's wharf, proved too much for some of the spiles, which had decayed, and a large piece of the wharf about 20 feet square—fell in and, with the ballast, sank to the bottom.

At the City Council on Thursday last a loan of \$20,000 was accepted from W. S. Sterling at 4 1/2 per cent.

A letter from the Secretary of the School Board informed the Council that the amount required to be assessed the City for School purposes for the ensuing year would be \$67,000.

The walking nuisance threatens to break out in Halifax. One of our papers notices that two young men propose occupying Mason Hall with such a feat for a purse of \$50.

The Dartmouth Civic election on Tuesday last resulted in choosing Dr. Weeks again as Warden, by a majority of 2 votes over Mr. Stairs.

Mr. Newberry has imported some Bass fish from the Hudson River. On Thursday last Capt. Greening pleaded guilty to the charge of shooting his wife, and threw himself on the mercy of the court.

SUGAR BEET.—The Agricultural Department of the New Brunswick Government have imported a ton weight of sugar beet seed from Germany for experiment in the raising of beets for sugar making and for cattle feeding this season. They have considerably placed a small portion of the seed at the disposal of the Nova Scotia Board at cost price. Agricultural societies wishing to obtain seed should apply at once to Professor Lawson.

A Plot among the prisoners in the Penitentiary was discovered on Saturday last. It was found that several had knives and hammers concealed about their clothes, and other preparations for violence and escape, which it is supposed was to have been attempted on Sunday. Two of the men named Hughes and Jarvis before attempted to escape, and once succeeded, but were re-captured.

H. M. S. Bellerophon accompanied by H. M. Ships Tourmaline, Druid, Plover, and Zephyr, arrived from Bermuda on Monday morning, and give a summer appearance to our harbor.
