Rev. C. H. Spurgeon's Church.

During the opening services of Mr. Spurgeon's
Great Tabernacle, a meeting was held the subject
for which was, "Our Own Church."

"Firm as the earth the Gosh Islands;
My Lord, my hope, my trust;

The Rev. C. H. Spurgeon offered prayer, in
the course of which he petitioned heaven that
the building might crumble, and the iron pillars
rust into nothingness

At the close of his prayer, he stated the object
of the meeting. The object of previous gatherings
had been to show that the Church of Christ
was one; this was intended to testify to the
interdependency, unity, and fellowship which each
Church of Christ had within itself

After his Father and several other ministers
had spoken, Mr. S. arose again and said there
were some peculiarities about their church which
were not to be found in any other. First, as a
church, for some little time they had maintained
elders in their midst—most churches had
deacons only, but none would deny that elders
were frequently spoken of in Scripture. They
were often told, however, that deacons and elders
were one and the same. He would ask, who
passed the law that the two offices should be
amalgamated? It was the very best plan he
knew that could be adopted in their church; for
without the elders it was impossible to exist,
but as a huge swarm or a mere presence. If his
deacons fell out, he fell back upon the elders; and
if the elders disagreed, he fell back upon his
deacons. As a church, they had made him the
happiest of ministers. He had found his mem-
bers to be a well of comfort, and a river of solace
to his mind. Another peculiarity was, that they
were Baptists, holding open communion views,
but admitting none but baptized persons to

spiritual doctrine—and he did not wish to be
dictated to by other people. He preached that
which he believed to be true. He was a lover of
John Calvin; but his doctrines were not what
was called Calvinism now-a-days.

REGULATIONS For the Management of the Crown Land Department, and for the Sale of Crown Lands in New Brunswick.

The Surveyor General shall make a Report of
the transactions of his Office, to be laid before the
Legislature at each annual Session.

2. He shall also from time to time submit to the
Governor a description of such tracts of
Crown Land as he may be disposed to recommend for
sale or for actual settlement, and shall annually
make up and submit a Schedule of the Lands pre-
sented for sale or for actual settlement, and which have
been disposed of during the year.

3. All Applications for Crown Lands must be
made in the name of the real applicant, and the
Grant shall be issued in the name of the purchaser,
unless his claim be transferred with the approval of
the Governor in Council.

4. The Lands to be surveyed in different
parts of the Province, as occasion may require, and
will be disposed of under the following conditions:—
Lands sold at Auction, and without conditions of
Settlement.

1st. Public sales of Crown Lands will be held on
the first Tuesday in every month, by the Local De-
puties thereunto appointed, in the several Districts.

2d. All applications shall be addressed by Petition
to His Excellency the Lieutenant Governor and
Governor, and transmitted to the Surveyor General.

3d. If the application be approved, and the land
applied for be not already surveyed, a warrant shall
forthwith issue to authorize the survey to be executed
at the expense of the applicant. No lot shall ex-
ceed two hundred Acres will be surveyed in different
parts of the Province, as occasion may require, and
will be disposed of under the following conditions:—
Lands sold at Auction, and without conditions of
Settlement.

4th. The upset price of such Lands shall not be
less than sixty cents per acre, exclusive of the
charge for surveying; twenty five per cent. to be
paid down, and the remainder in three equal annual
instalments, with interest at six per cent. per an-
num from and after the date the same becomes due.
If the whole amount of purchase money be paid
down at the time of sale, a discount of twenty per
cent. shall be allowed. In all cases of competition,
the lot offered for sale shall be struck off to the
highest bidder, who shall forthwith pay the purchase
money in full, or the first instalment of the purchase
money, and the instalments forfeited, unless the
applicant shall, within one year after the date of the
sale, have cleared at least two acres of the land.

5th. No person shall be entitled to a grant under
these Regulations, unless, within five years after
