## REGULATIONS

For the Management of the Crown Land Department, and for the Sale of Crown Lands in New Bruns-

1. The Surveyor General shall make a Report of the transactions of his Office, to be laid before the Legislature at each annual Session.

2. He shall also from time to time submit to the Governor in Council a description of such tracts of Land as he may be disposed to recommend for reser vation for actual settlement, and shall annually make up and submit a Schedule of the Lands previously reserved, shewing what portions thereof have been disposed of during the year.

3. All Applications for Crown Lands must be made in the name of the real applicant, and the Grant shall be issued in the name of the purchaser, unless his claim be transferred with the approval of the Governor in Council. 4. Tracts of Land will be surveyed in different

parts of the Province, as occasion may require, and will be disposed of under the following conditions :--

gland intends sending an expeditionary corps to Syria, and will occupy the territory between upper Syria and Eygpt.

Very, warlike rumors continued to prevail in Paris, and among others, it was stated that 60,-000 troops were suddenly ordered to Marseilles, aud that France was about to notify her intention of indefinitely prolonging the Syrian occupation. It was also said that sharp notes were exchanged almost daily with England, relative to the Syrian question. These rumors all lack confirmation, but they caused great uneasiness. Paris correspondent of daily News says Russia Las informed France that in consequence of events in Warsaw it will be impossible to join in any measure for settlement of Eastern question. Alleged reason for this is that Russia regards France as a accomplice in Polish disturbances.

AUSTRIA .- The Diet has unanimously passed a vote of thanks to the Emperor for the new law relative to Protestants.

Hungarian Chamber of Deputies definitively constituted, and held first sitting. President in opening speech laid stress on equality of rights of citizens and nationalities in Hungary.

POLAND .- A serious conflict has taken place in Warsaw. A great crowd of people having assembled before the Citadel, they were dispersed by force. The conflict was renewed several times. Tan persons were killed and as many more wounded. Five soldiers were killed Forty-five persons were arrested. Other accounts say that the number of victims was larger even than stated in the original telegram. A renewal of the disturbances was expected.

PRINCE GORTSCHAKOFF had issued a proclamation stating that assemblies for political discussions will not be tolerated, and that order can only be maintained by civil officers, with assistance of military.

National prayers in the Churches at Warsaw have been prohibited under threat of military interference.

ITALY .-- Garibaldi took his seat in the Italian Parliament on the 18th ; business temporily suspended by applause. The action of the Ministry n disbanding the Southern army, and measures taken for the re-organization were debated. Garibaldi made a speech so violent that it excited a tumult in the Chamber.

He made offensive allusions to the ministry, against which Cavour protested. The President of the chamber put on his hat, and the sitting was suspended for a brief interval. Garibaldi, in resuming, spoke with more moder .tion. He defended his comrades in arms, and said the formation of three divisions of volunteers, as decreed, was not sufficient for the national armament.

Gen. Bixo made a conciliatory speech. Cavour said he accepted the words of conciliation. Garibaldi explained several facts alluded to by Cavour, and exptessed his belief that Cavour loved Italy. He designated the French army as an enemy of Italy, because it occupies Rome.

All Regulations for the disposal of the Crown Lands heretofore promulgated are hereby cancelle saving however all acts and proceedings done, and all rights existing, accrued, and established, under such Regulations; and all proceedings now in progress thereunder, shall be continued and completed as if such cancelled Regulations were now in force.

Instructions to accompany the foregoing Regulations. 1. All Local Deputies making sales of Land shall make a Return to the Surveyor General within fourteen days after the date thereof, as also a statement of all instalments received within the previous month on previous sales. In this Return the names of the purchasers shall be inserted as also the names of Agents when the principal is not present at the

2. The Local Deputies shall also transmit, at the same time, a duplicate of such return and statement to the Receiver General, and remit to him all moneys received thereon, first deducting therefrom five per cent, which they are allowed to retain as remuneration for their services, provided such percentage shall not exceed four hundred dollars per apnum. 3. The Local Deputies shall severally give Bonds to the Queen, with two approved sureties in a penal sum of sixteen hundred dollars; conditioned for the faithful performance of their duty.

4. No Local Deputy, or other person holding an office under, or employed in the Crown Land Depart-ment, shall, while holding such office or employmen: lirectly or indirectly, purchase any right, title, or interest in any ungranted public Lands or Timber Berth, or deal or traffic in the same, either in his own right, or by the interposition of any other person or in the name of any person in trust for him ; nor shall he act as agent for any person in the application for, or sale of any public I and or Timber Berth or take or receive any fee or emolument for negoclating or transacting any business connected with the duties of his office or employment, beyond the compensation appointed for his services by the Government.

5. Every Deputy Surveyor shall notify the applicants, and execute the warrants of survey entrusted to him, within four months from the date of receipt : and the Plans and Reports shlal be transmitted to the Surveyor General within thirty days after the completion of the survey, such warrants bf survey as are not so executed shall be returned to the Crown Land Officeand be cancelled.

6. Every Commissioner for Labour to be performed in payment for Land, shall on or before the 15th day of December in each year, make a Return to the Surveyor General's Office, shewing the details of all labour performed as well as all Commission received by
