C LEGISLATIVE COUNCIL.

FRONTRICTON, April 11.—Hon. Mr. Young presented a petition from Robert Rossiter and 170 others of the Parish of Lancaster, praying for separate schools.

Hon. Mr. McInerney gave notice of the following Resolution for Monday next:

WHEREAS His Excellency in his speech, at the opening of the present session of the Legislature, foreshadowed a change in the School Law of this Province;

And Whereas, The proposed School Bill, as at present before the country, does not meet with the approval of a large portion of Her Majesty's faithful and loyal subjects within this Province;

Therefore Resolved, That the public education of the country should be based upon a principle that would remove all coercion of any denomination to contribute for the support of non-sectarian schools.

LOCAL LEGISLATURE.

FRONTRICTON, April 10.—The Provincial Secretary laid the Auditor General's report and that of the Chief Superintendent of schools on the table.

Mr. Crawford introduced a Bill relating to payment of damages assessed for lands taken for highway.

In reply to Mr. Wedderburn, Hon. Mr. Hathaway stated that the correspondence relating to unadjusted accounts would be introduced without an address.

Mr. Wedderburn's Bill to allow the rector, etc., of St. Paul's Church to hold bequests for charitable and pious use, agreed to in committee.
