- SINCE Prohibition went into effect in Raleigh, N. C., many of the saloons have been converted into factories. One of them employs more hands than were employed in all the saloons in the city while liquor was sold.

- THE TRIAL of Prohibition in Providence and vicinity proves, according to police statistics, that Prohibition has neuralgia, colds, sore throat, deafness, a most salutary effect on law-breakers. The arrests for drunkenness in the period named were only half as many as in the corresponding months in 1884; cases of assault and battery fell off from 53 to 20, of disturbances from 496 to 289, of vagrancy from 91 to 21, and the number of common drunks Miss O——, Toronto, writes: I have from 38 to 9.
