Also Resolved, that Bro. G. W. McDonald be associated with Bro. Trafton on this committee.

Report of committee on Quarterly Meeting. Your committee on Quarterly Meetings beg leave to submit the following:—

"We find there have been ten meetings held during the year, and without exception all have been blessed of God.

District No. 1 held 4 meetings and God's power and presence were manifested, souls were saved and sanctified.

District No. 2 held 4 meetings. They were seasons of victory. The meetings at Grand Manan were hindered by stormy weather, but the meetings at Jonesport were a grand success, bringing strength to the church.

In District No. 3 two meetings were held, one at Moncton and one at Sandford, and revival interest attended them from beginning to close.

We are sorry that some of our churches and also pastors have not taken the interest in this work which they might, believing as we do that no branch of work among us needs more hearty support of both pastors and people. We believe they fill to a large extent, the old-time conventions which were such a source of strength to us. We also feel that in this coming year we, as a people, should take a deeper interest in this work than heretofore.

"We the undersigned from your committee on temperance beg leave to submit the following: Believing that the use and sale of intoxicating liquors is one of the greatest evils that afflict our country, we desire to put on record the solemn vows of our denomination to use all our efforts to suppress the same. While we are unwilling to say that intemperance is on the increase, yet we see, with great regret, that Christian men and women are lukewarm in the cause of temperance, the subject being rarely mentioned by ministers or church members. Believing that legislation will not advance before public opinion we feel it is the duty of Christian men and women of all denominations to give greater attention to this subject in the future than they have in the past. And we particularly urge upon the ministers of our own body to greater faithfulness in this matter. And your committee respectfully recommends and requests that at least one session of our Alliance be devoted to the temperance cause and work.
