Many of the above papers required more time than was allotted to them. It was requested by the convention that they should be printed in book form. To give even a passing comment on the above papers and addresses would take much space. Thy were intensely interesting and very helpful. Dr. C. J. Fowler proved himself to be a chairman of marked ability, and was never forgetful of the spiritual side of this great convention. There was no time when a stirring spiritual song was not in order, and were frequently called for in the midst of the most interesting discussions.

The devotional services were held daily. Prayer, 6.30 to 7.30, and songs and devotions from 8.30 to 9.00 a.m.; from 2.00 to 2.30 p.m., and 6.30 to 7.30 p.m., open air service; 7.30 to

8.00 p.m., song service, followed by a sermon. Excellent sermons were preached by Revs. G. W. Ridout, G. A. McLaughlin, Dr. P. F. Breese, J. M. O'Bryen, D. F. Brooks, Dr. C. J. Fowler and H. C. Morrison. Rev. C. W. Ruth was the leader of a great love feast Sunday morning from 9.00 to 10.30 a.m. Evangelist Guy Wilson was the leader of a mass testimony and praise service from 2.30 to 3.30 p.m.

The music was a strong feature of the convention. This was in charge of Brother and Sister J. M. and M. J. Harris. A chorus of about three hundred voices occupied a place back of the platform, and augmented by a thousand voices on the floor and in the galleries, sent forth great waves of song from voices tuned by divine grace that could be heard for blocks away from the church. There was also special singing by male and female quartettes, and solos and duets. This is only a cold statement; the sensations produced upon those who were present can scarcely be imagined by our readers. On Sunday morning, just before the preaching service was to begin, two sisters were singing a duet, when suddenly a great wave of melting power swept over the audience of fifteen hundred people and a scene which no pen could describe broke upon us. The leaders on the platform, who are not impulsive men, clasped each other in their arms, a cloud of handkerchiefs were wiping the flowing tears; shouts of praise leaped from hundreds of lips; such a scene we never witnessed, when holy joy so completely permeated a great company of people.

A TIME OF PERPLEXITY.

Even this great gathering of God's people was not without its perplexing problem. This came in the form of a suggestion that the National Holiness Association be dissolved. The proposition created considerable discussion, and resulted in the appointment of a committee of nine to take into consideration the whole situation and to suggest some plan by which the general desire of the convention could be met, and the following report of the special committee was adopted:

REPORT OF THE COMMITTEE OF NINE.

We, the committee appointed by this convention to investigate the possibility of more fully unifying the various branches of denominational and interdenominational holiness work, would make the following recommendations:

First, that a series of evangelistic services be held under the conduct of our various associations, as fully as possible throughout the entire continent.

Second, we further recommend that another convention be held within one year, and that the "National" and 'Southern," and all other associations and bodies organized for the promotion of holiness be invited to attend and participate.

And we further recommend the appointment of a commission of nine, who, together with the said associations, shall see that such interdenominational and inter-associational convention shall be held; and who shall arrange for the same.

We further recommend that C. J. Fowler, H. C. Morrison, P. F. Breese, W. H. Foshier, Fred Ross, W. H. Hoople, John Paul, C. W. Ruth and Jacob Hoffman shall constitute said commission.

After a spirited and blessed meeting, it was announced that the committee of nine had decided to call a great holiness convention to meet in Cincinnatti, Ohio, the latter part of October next year. The committee has arranged for Drs. Morrison and Fowler to make a tour of the United States, holding three-day conventions in the interest of the great gathering next year. This announcement met the hearty approval of the convention. The secretary of the commission, Rev. C. W. Ruth, then announced that this tour and the necessary preliminary arrangements for the great meeting would require considerable money, and that they would ask for at least a thousand dollars. The convention was evidently ready to show its faith by its works, for in a very few minutes \$2,755 was pledged for the use of the commis-

In the evening the brass band of Chicago First Church led a street march of five hundred people. The crowds desiring to attend the evening service were so great that an overflow meeting was held in a large hall, and this, too, was filled so as to turn away many. Dr. Morrison preached in the church and L. Milton Williams in the hall. Both meetings were the occasion of special manifestations of divine power, and many were at the altar seeking the Lord.

We doubt if there has ever been held a gathering of holiness people which has had the farreaching results which this one bids fair to have.

The National Association for the Promotion of Holiness was organized in 1867 with Rev. John S. Inskip as its first president. He served till his death in 1884. Then Rev. William McDonald became president and served till 1894, when Rev. Charles J. Fowler, the present president, was elected.
