AUTHENTIC EVIDENCE OF THE RESURRECTION.

He showed Himself alive after His passion by many infallible proofs.—Acts 1, 3.

In treating the resurrection of Jesus Christ we are impressed with a sense of its tremendous importance. Christianity stands or falls with it.

If Christ be risen, what then? Then Christianity is divine and true; then Jesus of Nazareth is what he claimeth to be—the Son of God; then redemption on calvary is a glorious reality; then life beyond the grave is a fact; then the coming triumph of goodness is certain and indisputable.

The resurrection of Jesus Christ is an historic fact, and as such it is substantiated by infallible proofs.

The Christian Church is a witnessing fact. This is its creed, "If thou shalt confess with thy mouth that Jesus Christ is Lord, and shall believe in thine heart that God raised him from the dead, thou shalt be saved." The Christian Church is the fruit of Christ's resurrection.

The Christian Sabbath is a witnessing fact. It is not the original Sabbath. The Jews by their seventh-day Sabbath are raising the question from pole to pole, Why do the Jews and Christians keep a different Sabbath?

The Christian Sabbath is kept as a memorial of the resurrection of Jesus Christ, and as such it dates back to the time when the apostles saw the Risen One.

The resurrection of Christ is established by the testimony of competent witnesses of two classes, Christ's enemies and Christ's friends. They agree upon three things, Christ died, was buried in Joseph's tomb, which was sealed and guarded, and that on the third day the tomb was empty. The enemies had every motive to account for the empty tomb in a way to dishonor Christ. The same bitter envy and hate that surrounded the cross surrounded the tomb. Mark what the disciples met with because they proclaimed the resurrection. They were scourged and stoned and exiled! Are these the things which tempt men to become imposters? These witnesses gave the world its purest doctrine, and principles and ideals.
