# HOW I FIND THE WILL OF GOD.

By the Late George Mueller, of Bristol,

1. An Obedient Heart.—I seek at the beginning to get my heart into such a state that it has no will of its own in regard to a given matter. Nine-tenths of the difficulties are overcome when our hearts are ready to do the Lord's will, whatever it may be. When one is truly in this state, it is usually but a little way to the knowledge of what His will is.

2. Feelings Not Enough—Having done this, I do not leave the result to feeling or simple impression. If I do so, I make myself liable to great delusions.

3. The will of God Revealed Through His Word.—I seek the will of the Spirit of God through, or in connection with, the Word of God. The Spirit and the Word must be combined. If I look to the Spirit alone without the Word, I lay myself open to great delusions also. If the Holy Spirit guides us at all, He will do it according to the Scriptures and never contrary to them.

4. Providential Circumstances.—Next I take into account providential circumstances. These often plainly indicate God's will in connection with His Word and Spirit.

5. Prayer.—I ask God in prayer to reveal His will to me aright.

6. Deliberate Judgment and a Mind "at Peace."—Thus, through prayer to God, the study of the Word, and reflection. I come to a deliberate judgment according to the best of my ability and knowledge, and if my mind is thus at peace, and continues so after two or three more petitions, I proceed accordingly. In trivial matters, and in transactions involving most important issues, I have found this method always effective.

The special significance of this testimony lies in the fact that during his lifetime George Mueller provided for the maintenance and education of over 10,000 orphans at a total cost of over \$5,000,000, in addition to raising other large sums for day schools, Sunday Schools, and the circulation of the scriptures and tracts, and that he raised all this money through prayer, without any personal financial appeals. Mr. Mueller said: "I have joyfully dedicated my whole life to the object of exemplifying how much may be accomplished by prayer and faith." His deep experience of God gives his testimony about guidance very unusual weight.

# SAYINGS BY EVANGELIST JOSEPH OWEN.

It is written: "Be ye not unequally yoked together with unbelievers" (2 Cor. 6:14). This passage was doubtless originally intended as a warning against Christians being in anywise associated with idolatrous practices. But that it also applies to the marriage of Christians with unconverted persons there is no doubt. Dr. Clarke says, "Common sense and true piety show the absurdity of two such persons pretending to walk in a way in which 'they are not agreed." He also gives the opinion of a wise and holy man: "A man who is truly pious marrying with an unconverted woman will either draw back unto perdition or have a cross during life." And we would add, "Vice versa."

Too much can scarcely be said against a step that almost invariably involves lifelong sorrow and misery. As certainly as there is no fellowship between righteousness and unrighteousness, no communion between light and darkness, just so certainly can there be no true union of heart and spirit, so essential to happiness in the marriage relation, between a Christian and an unbeliever. The marriage of a Christian with a sinner is fraught with fearful consequences. ':'Be ye not unequally yoked together with unbelievers'' —with those who reject the Christ you love and trust.—Free Methodist. How important that we have both a good experience and also a good understanding of the doctrines of the Bible. The world can get a proper conception of divine truth only from those who have it. If we hold erroneous views as the children of God to the doctrines of the Bible, how is the world to get right views of truth? We should therefore follow the command of Paul and "study to show ourselves approved of God workmen that need not be ashamed rightly dividing the word of truth."—Christian Witness.
