BERWICK DISTILLERY STATEMENT BY GENERAL SECRETARY SOCIAL SERVICE COUNCIL

We learned on Saturday that a distillery license is being issued to the BERWICK BYPRO-DUCT COMPANY, OF BERWICK to manufacture liquor. The granting of this license is not in keeping with the message of the Federal Government to Steppanski on February 13th 1931. That message was to the effect that the consent given by Premier Rhodes was at that time, Feb. 13th, of no avail and license would not be granted without the written consent of Premier Harrington. Nor is it in keeping with the Department's assurance of April 27th, 1931, to the Social Service Council that a license would not be granted without written consent of Premier Harrington. That consent has not been given.

However it is reasonable to conclude that had the Harrington government made protest against the granting of a license to the Berwick Company, the Federal Government would not have issued a license. Both governments are responsible for the license of this company's distillery. The granting of this license favors the distillery interests of Canada whose business, as shown during the sessions of the Royal Commission on Customs and Excise, was characterized by evasion of law. The granting of this license by the Bennett Government is not in line with Mr. Bennett's stand as recorded in March, 1930, when he complained of the increase in the number of distilleries in Canada.

The granting of this license is an affront to the churches and various temperance organization from which earnest protests were sent to Ottawa. The granting of this license is an insult to the best citizenship of Nova Scotia, for at the heart of the Christian conscience in this country there is a conviction that the liquor traffic and the Christian Gospel stand for two diverse and contradictory conceptions of personal and social life.
