THE REFORMED BAPTIST YOUNG **PEOPLE'S ASSOCIATION**

The Reformed Baptist Young People's Association was organized at Beulah Camp Grounds on July 9th, 1932, at a meeting of young people held under the auspices of the Reformed Baptist Alliance, represented at the meeting by an Advisory Committee consisting of Rev. P. J. Trafton, Rev. H. C. Archer and Rev. H. S. Dow.

The following Constitution and Bye-laws were adopted:

CONSTITUTION

Article 1. This organization shall be known as "The Reformed Baptist Young People's Association."

Article 2. The object of this Association shall be to promote the cause of Holiness among the young people in all the churches connected with the Reformed Baptist Alliance.

Article 3. (a) The membership of this Association shall consist of its officers and two delegates from the young people's society of each church.

(b) Only those who are Christians shall be eligible to hold office or be received as delegates.

Article 4. !The officers of the Association shall be a President, Vice-President, Recording Secretary and Treasurer.

Article 4. The Association shall hold one general session each year at Beulah Camp Ground, at a time to be set by the Advisory Committee.

BYE-LAWS

Article 1. The officers of the Association shall be elected annually.

Article 2. The executive of the Association shall be composed of its officers together with three additional members to be appointed at the annual session.

We believe that the practice of mixed bathing is an evil, and further that it should be prohibited from a holiress camp ground.

We fear that not much of real benefit so far as legislation is concerned can be expected

Article 3. All members of the Association shall be eligible for office and shall have the right to vote at its annual meeting.

Article 4. (a) There shall be in connection with the Association four district Associations, corresponding with the quarterly meeting districts, which shall hold two meetings a year, in September and March, in each district.

The district officers shall be elected in the September meeting, to serve for one year.

(b) The District Association shall report at the annual session of the Association.

Article 5. Each District Association is requested to co-operate with the plan as outlined by the Association.

The officers elected by the Association are as follows: President, Lic. Bennett Cochrane; Vice-President, Mr. Edward Dow; Recording Secretary, Miss Lois Goodspeed; Assistant Secretary, Miss Gertrude Cochrane; Corresponding Secretary, Miss Winnifred Shaw; Treasurer, Miss Blanche Young.

The Association's slogan is, "Christ for the Young People, and the Young People for Christ."
