#### EDITORIAL

#### THE STABILITY OF HOLINESS

There are some things that are forever settled, and they do not need anyone or anything to help to steady them.

The holiness of God is a settled fact, and whether men believe it or reject it does not make any difference with Him, He still continues to be holy. God is settled in holiness.

The Word of God is settled. "Forever, O Lord, Thy word is settled in heaven". Ps. 119-89. "Heaven and earth shall pass away, but my words shall not pass away". Matt. 24-35.

We are at a time when men are seeking to bring stability to this old world. Nothing seems settled, one day there seems hope, then the next day it is dashed in pieces. There is nothing settled in this world, there has been changing conditions constantly. Nations rise and fall, empires crash and go down, but God and His word remain unchanged. Only truth is stable, and anything that is not of truth will not stand.
