TEMPERANCE REPORT 1936

Your Committee on Temperance regret that we cannot report any better conditions relative to the liquor traffic. The hypocritical profession of our government of interest in true temperance is "mere camouflage," and we observe abundant proof that the aim is not Government Control at all, but Government Sale. "The Government—the representative and trustee of the best thought and the highest ideals of the state, the supposed guardians of its morals and protector of its welfare and happiness," the government that we would wish to honor and hold in high regard has forfeited the true faith and respect of its people it is supposed to represent. After the positive failure of this experiment in controlling the liquor demon, if our Government were honest, it would acknowledge the failure and rid itself of the approbrium of being engaged in the liquor traffic. We cannot resist crying "Shame" on a Government that would sell its people for money, and divert the money to itself and brewers that should be used for the needs of the home. Samuel Johnson said "To support government by propagating vice is to support it by means which destroy the end for which it was originally established and for which its continuance is desired." And can the Governmet control the traffic? True, there has been some effort made but to sell it and then try to control it is childish folly. We quote an editor in Nova Scotia who recently remarked that if the same efforts had been made to enforce Prohibition, something might have been accomplished. Control may be possible on the shelves of the Government Stores, but after the flask is passed through the wicket and slipped in the pocket of the purchaser, the control ceases. Evangeline Booth says: "It is not Prohibition alone that the liquor trade defies. It is any law that at any time restricts the flow of liquor in any way."

The American Motorists Insurance Co. in a report says: "Politicians who promised faithfully that the saloon would not return, promptly forgot those promises as soon as the election was over. The result is that not only has the saloon returned, but the regulation of the liquor traffic is probably the most lax the country has ever known." Witness to this fact is the increasing drunkenness with its resultant increase in crime and accidents. The National Safety Council has gathered statistics which show that the influence of alcohol on traffic accidents has greatly increased since the repeal of prohibition. An appeal has been made by Los Angeles traffic officers to business executives to help devise methods to decrease drunken driving. The only method we could suggest would be to dispense with the sale to the drinker.

Is then the bootlegger being controlled?

New York State collects taxes on less than one-half of the liquor drunk and a report to a Senate finance committee states that 50% of distilled liquor goes tax free. The New York Times in an article reviewing the first two years under repeal says: Authorities think that one glass of illicit liquor is consumed for every legal drink. More people, particularly the middle class ,are drinking. We have brought these opinions not only from prohibitionists but from the calculations of business men and companies.

We feel then to strongly protest against the whole traffic as it is now directed by our government. It has utterly failed in its pretended object. Our youth is degraded. The time was when the saloon was satisfied with the men and boys-now it takes our women and girls and even children of tender years are offered and taught to drink. It has failed to eliminate the bootlegger, to relieve unemployment, to reduce taxes, to avoid advertising in papers, on bill boards and radios.

We protest against it because it is morally wrong and no legislation can make it right. "It cannot be legalized without sin and the Bible inspired of God puts prohibition on the whole dreadful traffic." While we do not expect to make men righteous in heart by legislation yet we believe much good can be done in the way of moral betterment by the continued opposition and aggression of Temperance farces. The liquor traffic fears energetic prohibitionists and makes efforts to prevent their broadcasting. "Col. Jacob Ruppert, Pres. of the U.S. brewers, in addressing the National Convention made this statement, 'We brewers need to launch a national fight against professional prohibitionists. In eight or ten states there is already danger of drifting back toward prohibition unless a concerted fight is made against it."

Let all who desire peace and safety, who love the youth of our land, who yearn to remove temptation from a weaker brother, who seek to honor God and serve humanity, realize that "Now it is time to 'Arise and Build' the broken walls around the holy city of Home and our God will be with us as He was with Ezra and Nehemiah.
