perfect love, and yet retain the consciousness of a justified state." (Major).

It is well that we have a tender solicitude for the backslider, not a bitter spirit. A certain writer wisely says: "When we take into account our own weakness and susceptibility to temptation, it should behoove us not to be too severe and unmerciful in dealing with others. Sometimes people who spend much time and effort in winning a soul to Christ do not seem equally concerned for his welfare if he is overcome by temptation and falls into sin, but rather adopt a critical and censorious attitude which is likely to drive him farther away rather than to draw him back to God. The soul of the backslider is worth as much as that of the sinner who has never been saved, and patient and loving effort should be made to reform him again."
