MINISTERS—COMPULSORY RETIREMENT

The United Presbyterian is responsible for the following item:

"The compulsory retirement of ministers at the age of seventy will become the law of the Southern Presbyterian Church by order which was recently approved by the General Assembly for submission to the presbyteries. Under the terms of the proposed amendment all pastors, associate pastors, assistant pastors, and stated supplies must terminate their services in their respective churches on Sept. 1st, following their seventieth birthdays, unless they be re-elected 'for one year at a time not to exceed three years.' Many attempts were made in the General Assembly to defeat this measure but all were voted down."

This idea would be good provided it were true that seventy is the age until which men are universally useful, and after which they are invariably useless or nearly so. But this is very far from true.

There are some men who once seemed to serve well, but at fifty years have ceased to function to the good of the charges they serve. Why should such men be led to believe that they can have twenty years of appointments, leaving the work worse than they found it at each place, because there is a seventy-year law, and because there is not courage with the appointing authorities to do what ought to be done? On the other hand, some men have done as good work after they are seventy as ever in their lives, and some have served even better than ever after the three score years and ten are past. Must general assemblies and general conferences and individual churches tie themselves under rules which might be embarrassing because those governing or selecting or appointing bodies lack the courage or the intelligence to do what ought to be done in an individual case?
