TED HOBSON HEALED

A number of our people will remember that Ted Hobson had a tumor removed from the top of his skull in July. He was stricken with a very rare disease known as eosiniphilic granuloma.

On August 1st, the day we commenced our vacation, the radiologist at the Victoria General Hospital informed me that Ted had a tumour on his pelvis and wanted to commence x-ray therapy right away. The doctor suggested that we take our hodidays as planned and upon our return to the city they would start the x-ray treatments.

After our vacation was over I took Ted to the hospital. However, before we went I prayed very definitely that the doctor would find no tumour on Ted's pelvis. A new set of x-ray plates were taken and the doctor informed me that there was no tumour to be found on the pelvis. God had answered prayer.

On October 7th another tumour was discovered on the back of Ted's skull. The next day we went to the hospital to have x-ray pictures taken. The radiologist reported to me that undoubtedly there was a tumour there and that the condition was generalized. A report of Ted's condition was given to our own doctor, Dr. Leon Green. Dr. Green was greatly concerned over Ted's condition. He said above the power of medical aid there was the power of prayer and the power of God. After deciding that nothing could be done in Halifax for Ted, Dr. Green wired the Lahey Clinic in Boston and made arrangements for Ted to come under their care. On Friday, October 21st, he was admitted to the New England Deaconess Hospital. He was given a thorough examination and a number of x-ray plates were taken of his head and body. Before too long the tumour on the back of Ted's skull was hardly noticeable. On Tuesday, October 25th, Dr. Edwin Lang, one of the leading neurologists of the Lahey Clinic, gave us a report advising us that we could return to Halifax. The tumour was disappearing and he did not think it advisable to recommend any treatment. Upon our return to Halifax Dr. Green requested to see Ted and examined him for his own satisfaction. Dr. Green could find no trace of the tumour; it was completely gone. He said it was the power of prayer and that it was unbelievable. He gave God the credti for Ted's recovery. Before leaving for Boston, I asked the Lord for some word of assurance concerning Ted. On two occasions God gave me the same promise, "With long life will I satisfy him and show him my salvation." That was sufficient for me. To all our friends who prayed for Ted, Mrs. Hobson and I as well as Ted, say "thank you" and express our deepest appreciation. It is wonderful to know the Lord when adverse circumstances enter your life and it is also wonderful to have many kind friends to stand with you in prayer. In addition to our Reformed Baptist friends who remembered Ted in prayer, churches in Ottawa, Cambridge, Mass., Brooklyn, N. Y., Glace Bay, New Glasgow, Sydney and Halifax also had special prayer for Ted.
