(I was so glad as I have often gotten colds from walking through the wet grass to tend my patients).

Then the doctor told me something that made me fairly jump for joy, viz., that he thinks that the Town Board will soon try to undertake to build us a suitable building for me to take cases in, instead of having such hardships as I have had to endure in many of the homes. He knows as no one else what I have had to put up with —and what a hard job it is anyway.

He is so helpful and I was surprised he was so understanding and sympathetic. He asked about my girl for the Clinic. I told him I had at last got one, day before yesterday, and was trying to break her in. He said he hoped we could get a trained one after awhile to help me! My! How thrilled I was. How my heart went up in praise to God! The Women's Institute has become interested in this work, through him, I believe, telling them of the financial situation, that there was no money on hand for supplies and how he had gotten these for us on credit. They became concerned and gave half of the amount they had raised, with some other purpose in mind, for the Clinic—L25.0.0., about \$75.00. So here was further cause to rejoice and praise the Lord.
