B., Friday, May 22nd at 10.00 a.m. The meeting is called to consider a recommendation of a joint committee composed of members of the Alliance Executive and Bethany Bible College Board "that we purchase buildings at Sussex, N. B., for the relocating of Bethany Bible College". As stated in the Manual, page 45, Article 2 of the Constitution, "local churches shall be entitled to representation in the Alliance as follows: (1) two lay delegates from the local Church; and (2) one delegate from the local Missionary Society. Ordained ministers of the Alliance, in good and regular standing, are also qualified to vote in Alliance meetings.
