but—the last piece has not been laid on God's altar of sacrifice. And the fire will not fall until the sacrifice is complete.

Let us be honest. Let us be realistic. I believe we are not going to see the revival we long for, and the streams from the river of God, until Christian men and women cry out to God, "Lord, take the last piece!" If the fire of God is to fall—the last piece must be laid on God's altar!

I shall never forget hearing that dear saint of God, Dr. Inward, cry at the 1924 Keswick Convention, "Christian men and women, self-renunciation is the cardinal ethic of the Christian Church."

Is it not true, too often our very best moments of yielding and consecration are mingled with the destructive element of self-preservation?

A full and complete surrender is the place of blessing—but that also is the price of a heaven-born revival.
