Rev. H. R. Ingersoll DEBT REDUCTION SUNDAY

There are a number of days in our church year that are designated as days of special financial appeal. All of them are important. Without the faithful support of our people to these various appeals, we would not be able to carry on our work. Over and over again in response to our departmental appeals you have given liberally. We want you to know we deeply appreciate your faithfulness.

However, there does seem to be one area of our denominational program that many of our churches fail to take as seriously as we should. I refer of course to our General Treasury. This is the treasury that inherits all bills that are not directly related to Home and Foreign Missions or Bethany Bible College. This places a much heavier demand upon our General Treasury than most people realize. Many times action is taken in Alliance which obligates the General Treasury without making financial provision for the added burden. While this department is operating its current responsibilities within the bounds of its annual budget, over the past number of years there have been unexpected demands that have necessitated the borrowing of funds.

To liquidate this indebtedness is a worthy objective, the accomplishment of which would be pleasing to God. This \$12,000. goal can be attained within five years or less without undue strain if ALL our pastors and churches will promote and support the Debt Reduction Offering on January 16 to the best of our ability. Since the General Treasury is the carrying beam of our denominational program, it is imperative that we maintain it at a satisfactory operating level.

This is an earnest appeal for your full co-operation and support. Let us establish a new record in our giving to Denominational Debt Reduction this year!
