W. R. Gould, D. Secretary, in a neat, pleasant, forcible manner showed the evils and dangers of young men drinking liquor. Mr. Gould, although the hour was late, held the attention of the audience and made the speech of the evening.

Altogether the meeting was one of profit and interest. On behalf of the District Lodge members visiting Sackville, your correspondent wishes to thank the members and friends of Sackville Lodge, for their kindness and hospitality.

The session throughout was very pleasant, and the outlook for Good Templary in the country was never better.

ST. STEPHEN.

Sixteen cases have been tried here this summer under the Canada Temperance Act and conviction has followed in each case but the cases have all been carried up to the Supreme Court on one little technical point, that the magistrate trying the cases is an interested party being a property-holder in the town.

It is thought that when the cases are argued before the court in October this objection will be overruled and the fines can then be collected, only one of them having been paid so far.

It is hoped in the interest of good government and all that is moral and religious that these objections may be all swept away and the law allowed to take its course as it was intended it should, then there would be some encouragement to work for the suppression of the rumshops which are doing so much injury in this community today.

Next Friday night another set of officers will be chosen to guide the division through an important quarter, coming as it does at the conclusion of the heated term when the attendance has fallen off, and ushering in the long evenings when outdoor attractions cease to be alluring and preparations are being made for the long winter ahead of us.

The success of the division through the coming winter I believe will largely depend upon the choice of officers for the ensuing quarter, so it is necessary that wisdom should be exercised in selecting those into whose hands is to be intrusted to a large extent the welfare of the division.

Next Friday night also we decide the question whether or not the division will lease a hall in the building to be erected by the W. C. T. U. I need hardly add that we will undoubtedly decide to take the hall for we will be only too glad to be tenants of such a noble band of temperance workers and to assist them all in our power in so laudable an undertaking. The Grand Chaplain was present last night of meeting and gave us a short sketch of his journeyings and the impressions he received of the progress of the great temperance reform in those parts of the United States which he visited, from which we glean that this important question is receiving more attention today than ever before in the history of the world.

Bro. W. H. Stevens who had just returned from the S. S. Convention in Fredericton gave us an account of his visit to Lansdowne division and of the work done there.

Yesterday was the anniversary of the bombardment of St. Stephen by the Salvation Army and was celebrated by them with appropriate services at their barracks in Chipman's hall. While we may not subscribe to all their creed and may disapprove of much of their method of conducting their warfare against sin and the Devil we cannot but admit that they have done a wonderful amount of good among a class of people not easily reached by the churches, and not only among them but among all classes have they accomplished good. In temperance work they have made some wonderful reformations, one in particular, that of the conversion of one of the lowest, sin-hardened rum-sellers we had in town, is in itself worth a year's work. The man, today is living an upright life and working hard at honest labour. This is only one of many wonderful reformations of which I am personally able to bear witness, and I know they have been a great aid to us in our work among the drinking men of this town for many who are now consistent members of our division were influenced in their meetings to give up the degrading habit.

The character of the officers stationed here has had much to do with the success which has attended their efforts. It is to be regretted that the rules of the organization do not admit of the continuation in one place of the same officers for a longer period than six months, for it is doubtful if a change at the present time will be beneficial to the army in this town.

Capt. Schaeffer whose time here is nearly up has endeared herself not only to the soldiers under her but also to the Christian people of the community by the way in which she has conducted the campaign while she has been stationed here. Mild and refined in manner, she endeavoured to rule more by spirit of love than by the assertion of authority and her influence for good, will be missed in the community.

In Cadet Wilson she has a worthy assistant and she too has won hosts of friends who will miss her when she goes away. Such officers as these two do much to remove the prejudice which exists to a large extent against the army and its methods and I hope we may have more of their stamp when it is necessary to make a change. I have dwelt at some length on this subject of the temperance work of the army because I wish to acknowledge and bear testimony to the grand work which the Salvation Army have done and are doing in our midst and to render "honor where honor is due."

If my letters are too long Mr. Editor just drop me a line to that effect and I will try and cut them down, for when I get started on this subject I don't know when to stop.

I should like to see more of our divisions represented in the correspondence department of the JOURNAL for I believe we can encourage and strengthen each other greatly by telling how the good work goes on in our respective localities.
