## LEGISLATURE PROROGUED BY GOVERNOR WOOD

(Continued from page 1)

The House went into committee with Mr. Sweeney in the chair, and considered the bill to amend the highway act for Victoria County.

Hon. Mr. Flemming said he was opposed to the bill but the Government in introducing the highway act assumed a responsibility of its provisions and therefore any amendment should emanate from the Government. In the present instance the amendment was presented by the hon. gentleman from Victoria from the Municipal Council. The representation of the municipal council would receive the best possible consideration if presented to the Government.

Mr. Tweeddale said that he had received the bill from the Municipal Council and expressed a desire that the proper course should be taken in respect to it, as indicated by this hon. friend.

The Committee reported progress without leave to sit again.

The bill relating to the town of Campbellton was agreed to as amended.

### FREDERICTON ELECTION BILL

The committee went into consideration of the bill relating to the election of the Mayor and aldermen of the city of Fredericton.

Mr. Bentley said that the amendments to the bill as presented by the City Council had been adopted only by the vote of the chairman after there had been a tie. While some of the members claimed they desired a secret ballot it seemed strange they voted against the original bill which in his opinion gave the best possible secrecy.

Hon. Mr. McLeod said his hon. friend pursued his usual course of inconsistency and made his objection because he wanted to make political capital. He (McLeod) desired to have the best secret ballot available and he felt the provincial ballot suited the purpose. If his hon. friend was so interested in giving this secret ballot why had he not placed such a ballot in the St. John Commission bill.

Mr. Bentley said he could not see how it would be possible to make political capital out of his objection. He believed the citizens would come to this legislature and get a form of secret ballot similar to the Fredericton bill.

Hon. Mr. McLeod—Will my hon. friend say that the ballot provided in the amended bill is not secret.

Mr. Bentley said it was not as secret as the ballot proposed in the original bill.

### MCLEOD GOT WRATHY.

Hon. Mr. McLeod said under the amended bill every elector could vote as he desired and absolute secrecy was assured. The hon. member for St. John (Bentley) never addressed this House but he assumed the air of the Pharisee who thanked God that he was not as other men were. He alone was sincere and honest. It was an assumption that was entirely hypocritical for him to say that hon. members who supported the secrecy of the ballot as proposed by the amendments talked one way and voted another, but such statements were entirely in keeping with the course of the hon. member on every question before the House.

Mr. Copp said that a large number of the electors of Fredericton favored the original bill which had been introduced by the provincial secretary, who would be supposed to support it.

Hon. Mr. McLeod said that he always supported the principle for secret ballot.

Mr. Copp said his hon. friend from St. John was perfectly within his rights to offer objection to the amended bill and he (Copp) was also of the opinion that the ballot under the original bill was the better.

Hon. Mr. Maxwell said the ballot provided in the amended bill was a secret ballot and even more secret than the Dominion ballot as provided in the original bill.

Mr. Currie said if the motive behind the movement was for the enforcement of any law the more secret the ballot the better.

Hon. Mr. McLeod asked if the hon. gentleman knew of any city or town which had the Dominion ballot.

The amended bill with the amendment carried.

### THE GAME ACT.

The House went into committee, with Mr. Baxter in the chair, and considered the bill to amend the Game Act.

Hon. Mr. Flemming said the bill provided that licenses should not be granted to minors under sixteen years of age. The open season for muskrat was changed so that the dates would be March 25th to May 15th, the length of the season remaining the same as before.

Mr. Young moved that an exception be made of York County and the date for that county for the open season be from Oct. 1st to Jan. 1st. This was lost.

Mr. Shipp said that there were many cases where farmers should be allowed to kill one or two deer on their own property.

The closed period for beaver was extended to 1915.

Mr. Young said there was a demand in York County for a bounty on porcupine, which were killing pine and spruce trees in great numbers in York County.

Hon. Mr. Flemming said he would have the matter investigated.

The bill was agreed to with amendments and the committee took recess at 6.20 o'clock.

The House went into Committee with Mr. Dickson in the chair and agreed to the bills to amend the New Brunswick Joint Stock Companies Act to amend the Registry Act, and to make further provision for permanent bridges and works of a permanent character with amendments.

Mr. Shipp said he was pleased to see that the Jerneg Bridge was included in the list of permanent structures to be built this year from the amount of \$300,000. He was sure the people of that section of Queens County would appreciate the action of the government. It was a very dangerous place both in winter and summer and on an important thoroughfare. The bridge had been sought after for many years and the people had been very patient in their very deserving claims.

### MR. PERLEY'S KICK

In reply to Mr. Perley Hon. Mr. Morrissey said that the loan of \$300,000 was for the bridges mentioned in the bill.

Mr. Perley said that had he known that the amount was for these bridges only he would not have supported the bill.

In reply to Mr. Bentley Hon. Mr. Morrissey read the names of the bridges which would be constructed.

The bill to confirm the agreement between the St. John and Quebec Railway and the governments of Canada and New Brunswick and to amend the act incorporating the St. John and Quebec Railway Company was then considered.

Mr. Bentley asked if there was any assurance as to what percentage of the through freight receipts the province would receive.

Hon. Mr. Flemming said that the matter had been discussed with the minister of Railways on the local freight rates the province would receive 40 per cent. The Government railways did not come under the jurisdiction of the Railway Commission but in the matter of through freight rates he had no doubt that there would be a fair and equitable division of the receipts.

Hon. Mr. Flemming to Mr. Robinson said that provision was made that the stock issued by the company would represent an actual cash consideration. The financial arrangements of the company insured an amount for the issue of the unguaranteed bonds and the issue of stock.

The bill was agreed to. The bill to incorporate the Miramichi Valley Railway Company was agreed to with amendments, and the title of the Company was changed to the Miramichi Bay Shore Railway Company.

The House went into committee with Mr. Munro in the chair and agreed to the bill to amend the act to provide for the protection of the woods from fire also the bill to amend the act respecting the Public Utilities Commission, and the bill to amend the act to allow the St. John Railway Company to extend its lines into Kings County.

On resuming the House went into committee with Mr. Munro in the chair and took up the bill respecting the Durant Sugar Refinery in St. John.

Mr. Wilson moved that the committee report progress without leave to sit again. After some discussion, Mr. Wilson's motion was carried by a vote of 16 to 10.

Hon. Mr. Flemming moved that when the House adjourned it stand adjourned until Saturday at 11 a. m.

### DEATH AT DOAK SETTLEMENT

The death of Miss Sarah Ann Mul-lin occurred this morning at her home, Doak Settlement after a lingering illness. The deceased was aged fifty-four years and is survived by one cousin John M. Graham with whom she made her home. The funeral will take place Sunday afternoon leaving her late home at one o'clock. Services will be held at St. Dunstan's Church at 2.30 and interment will be made at the Hermitage.

### UNIONIST MEMBER RETAINS THE SEAT

London, April 20—The East Notting-ham bye-elections, caused by the retirement through ill health of Captain Morrison, resulting in a unionist majority of 1,324, the figures being: Sir John Rees, 6,482; T. W. Dobson, Liberal 5,158. This was the first bye-election in which home rule was made a leading issue.

## 1635 LOST AND 705 SAVED IN TITANIC WRECK

story of her experience, as repeated practically verbatim by the physician is as follows:

"We had already retired when the jar of the collision came. We thought little of it, but Mr. Astor was interested and said he would go on deck and see what was the matter. I called my maid, and put on a light dress, planning to follow in a moment or two. Pretty soon, Mr. Astor came back and said that he did not think it was anything. The ship had grazed some drift ice he said. We didn't know then, that it was a giant berg. He was very calm and so I was not alarmed. We put on ordinary light clothes and went on deck together. Everything was extremely quiet. No one was excited, least of all Mr. Astor and myself. We walked around and people began to pour up on deck. The excitement began to grow, but the ship seemed all right. Then the order was passed around to get out the boats, but nobody wanted to get into them and the first ones lowered were only partly filled.

The situation did not begin to get grave until most of the boats were gone and there were only two left.

Mr. Astor put me and my maid and nurse into one of the boats and stood calmly as the boat was being sent away. Before the boat was lowered, he sent for some heavy wraps, and furs for us. The boat pulled away from the Titanic and began almost immediately to ship water, until I was up to my knees. I occupied my time bailing.

Before the arrival of the Carpathia we picked up six men, two of whom died immediately after being pulled aboard.

### BECOMES A BRIDE

New York, April 20—One of the girls, survivor of the Titanic, Miss Marion Wright, of Somerset, England, will be married here late today, to Arthur Woolcot of Cortage Grove Oregon. She came alone from her home in England to meet her fiance here, and he has been in New York for nearly a week anxiously awaiting her arrival.

The pair were school mates in England and became engaged before Mr. Woolcot left to become an Oregon fruit grower. They will leave for the west tomorrow.

Hamburg, April 20—The Hamburg-American Line has been quick to a lesson from the Titanic catastrophe. It has decided to increase the number of lifeboats on its steamers although they already carry more than are required by the German law, and it will also improve all life saving appliances, so that under any circumstances, every person on board can be accommodated.

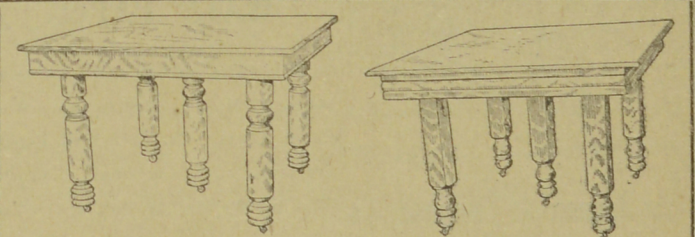
